Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of September 12, 2017 for:

1. Excel spreadsheet showing number of staff for 2014, 2015, 2016, 2017 (up to August 23) regarding Animal Control resources such as full time equivalent number of employees including supervisors, managers and part-time and seasonal staff working in Animal Control;
2. Any City of Vancouver or Parks Board wildlife management reports from January 1, 2015 to August 23, 2017 in the City of Vancouver (for example, an account of any of efforts or progress reported to "control, manage, improve safety of the wildlife population in the City" specifically interested in coyotes, ducks, geese, raccoons, swans and herons).

All responsive records are attached for Part One of your request.

In regards to Part Two of your request, the Park Board confirms they do not have any responsive records as formal reporting of this type does not take place.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2017-317); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
