Letter of Intent On further Cooperation and Exchanges Between

Shanghai Municipal People's Government, People's Republic of China And

The City of Vancouver, Canada

Whereas, each of the City of Vancouver of Canada and the City of Shanghai of the People's Republic of China, is a city of significance and major impact to their respective country; and great potentials for cooperation and exchanges exist between the two Cities in multiple sectors.

Now therefore, based on the principles in the Joint Communiqué of the Government of Canada and the Government of the People's Republic of China Concerning the Establishment of Diplomatic Relations Between Canada and China, and for the purposes of deepening the friendship between the people of the two countries, and further enhancing the friendly exchanges and cooperation between the City of Vancouver and the City of Shanghai, the two Cities have reached the following terms of shared intent:

- 1. The two Cities will endeavor to encourage and support economic and trade exchanges and collaboration between businesses of the two Cities.
- 2. The two Cities will endeavor to increase exchanges and collaboration in

such sectors as technology and innovation, environment protection, culture, healthcare, transportation, tourism as well as urban administration and management.

3. The Asia Pacific Trade and Investment Centre of the Vancouver Economic Commission and the Foreign Affairs Office of Shanghai Municipal People's Government shall be the designated agencies responsible for the liaison and implementation of the initiatives under this Letter of Intent.

This Letter of Intent is written in English and Chinese, with both versions being equally valid and effective. This Letter of Intent is executed as of September 8th, 2017 in Shanghai, the People's Republic of China, with two original executed copies.
