#### Sadhu:

Pursuant to our conversation this afternoon, here are some of the facts that the City should consider regarding Parq's efforts in the area of job creation and, specifically, its handling of the collective bargaining unit issues: <u>Parq Operations Phase Employment:</u> Parq Vancouver will employ 1,694 full time equivalent associates, which equates to approximately 2,078 full time and part time jobs, with a projected annual payroll of \$85,248,324:

- Parq is committed to ensuring 10% of the +2,000 full and part time jobs will be opportunities for Vancouver residents living in the proscribed catchments areas or who are unemployed, underemployed or marginalized in the current job market.
- Currently, there are 910 full time and part time jobs at Edgewater Casino, of which 754 are casino employees and 96 are food & beverage employees. All Edgewater employees will be transitioned to Parq – <u>there have been</u> nor will there be any layoffs.
- When Paragon purchased Edgewater Casino in September 2006 many of its casino and food & beverage employees were members of the CAW collective bargaining unit, which had 448 (399 casino; 49 F&B) members at that time. As of September 1, 2017 there are 591 casino employees and 82 food & beverage employees who are members of Unifor, for a total of 673 existing union jobs at Edgewater.
- In February 2016, Edgewater informed Unifor and all Edgewater food service employees that when Parq Vancouver opened, all food and beverage functions outside of the hotels would be managed by a third party, as the scope and scale of Parq's food & beverage program needed to be implemented and managed by a recognized expert. Parq Vancouver includes eight separate food & beverage venues, each of which is a unique, stand-alone facility catering to the dining and beverage needs and expectations of Parq's diverse customer base.
- In June 2017, Parq Vancouver announced that BA Restaurant Holdings LP, a highly respected restauranteur, would manage the Parq food and beverage venues. Founded by Elizabeth Blau and her husband, Chef Kim Canteenwalla, the Blau group are generally acknowledged in the industry as being a major catalyst for the "celebrity chef" direction top tier restaurants have taken over the last decade.
- BA Restaurant Holdings LTD is hiring 482 full time equivalent food & beverage employees, or approximately 667 full time and part time jobs. All Edgewater food & beverage employees have been offered the choice of either transitioning to BA Restaurant Holdings LTD or staying in the collective bargaining unit and transitioning to casino or customer service positions.
- As of September 1, 2017 over 50 of the 84 Edgewater food & beverage union employees have expressed interest to work for Elizabeth Blau, as it will give each of them a unique and extensive opportunity to learn the restaurant business hands-on through exposure to a wide spectrum of cuisines and skills created by top tier chefs and culinary experts, with excellent opportunities for advancement.
- Parq Casino is transitioning all 754 Edgewater Casino employees to Parq Casino, which will require 900 full time equivalent employees, or approximately 1,024 full time and part time jobs.
- Parq Casino is currently hiring 270 additional full time and part time employees: at opening, Parq Casino will have 861 employees in the collective bargaining unit, an increase of 188 members, or 128%, over the *total* existing union members currently at Edgewater.

Sadhu and Paul,

Kathryn and I visited the Parq Casino this afternoon and had a meeting with a number of the senior team members, including John Cahill. We had a clear conversation about our expectations based on Council's intent and what was spelled out clearly in the covenant and development permit - i.e. no expansion of gaming. We discussed the notion that the number of tables cannot serve as the common denominator of this, particularly if they have any intention of doubling tables. We agreed that 'seats' or 'gaming positions' was a better metric to show the amount of gaming and that they would produce a report for us by the end of next week indicating that that have not increased the number of positions. In our meeting today, they provided some basic numbers that demonstrated that their net seats are actually less, because (essentially) they have some smaller tables and some bigger tables.

They seem willing and interested in cooperating and have put in place a lot of responsible gaming initiatives. They agreed that if they intend to change table sizes or positions in the future, they will engage the city. I expect to see that included in the report.

Based on the discussion and their commitments, we left the meeting comfortable with them moving forward with operating as designed and set up. This is a different outcome than we expected going into the discussion, but they provided enough evidence that they're not currently expanding gaming that we felt it was fair to allow them to open as they expected.

We will continue to monitor the situation and will report back if their report doesn't meet our expectations.

Thank you very much for the opportunity for our team to meet with Kaye and Kathryn Friday afternoon to discuss the expansion of gaming issue and the need to find a mutually meaningful and acceptable metric that can objectively measure what constitutes "an expansion" of gaming. I really appreciate the time Kaye and Kathryn took to listen to our take to the overview of the issue and the resultant discussion on how best to move forward.

Our team met today to begin the preparation of a report which we will have to you by the end of this week. The report will be based on the "bums in seats" approach that we landed on Friday, and will use that metric to determine a baseline capacity at Edgewater and the opening capacity at Parq.

I believe this analysis, presented in the context of Parq's overall casino experience and commitment to responsible gaming, will demonstrate to the City that Parq is not expanding gaming, but doing everything it can to deliver gaming in a responsible manner.


