The voter identification and registration requirements for municipal elections are governed by the Vancouver Charter (including sections 25, 26, 30, 30.1, 32, 87 and 128) and the Local Government Elections Regulation BC Regulation 380/93 (Section 3). Under Section 32 of the Vancouver Charter, the City uses the most up-to-date and available Provincial list of voters as the City's list of registered voters.

If a resident is not on the City's list of registered voters, under the Vancouver Charter, the resident may register as a resident elector at the time of voting. The individual must be a Canadian citizen 18 years or older who has resided in the Province for at least six months and the city for at least 30 days prior to the date of registration. The applicant must produce at least two documents that provide evidence of the applicant's identity, place of residence, and signature. The identification documents are set out in the Elections Regulation (Section 3) and may include a solemn declaration as to the applicant's place of residence.

However, if the resident is on the city excerpt of the Provincial Voters List, they are not required to produce voter identification when voting in the municipal election. This is clearly set out in the above mentioned sections of the Vancouver Charter. The same rules are also set out in the Local Government Act that governs elections for all other municipalities in the Province. As such, it is a contravention of the provincial legislation to require a voter to produce identification if they are on the register of resident electors (i.e voters list) for the city unless challenged under section 88 of the Charter.

Prior to receiving a ballot, each resident elector is required to sign the General Voting Book in accordance with the Vancouver Charter. In signing the book, the resident elector is swearing that by signing the book, they are declaring that they are entitled to vote in the election and that they have not voted before in the election.

Section 87 refers to the requirements before an elector may be given a ballot to vote. Section 87(1)(a) clearly indicates that if a person is not shown on the list of registered electors, the person must register in accordance to section 30 or 30.1. Section 30 sets out the requirements for identification. Section 87(1)(b) clearly indicates that if a person is on the list of registered electors, the person is only required to sign the voting book indicating that they are entitled to vote and have not voted before in this election.

Section 88 applies in the event of a challenge of the elector. If an election official, candidate representative, or an elector does not believe the individual is entitled to vote, they may challenge the individual. It is a formal process and under section 88(3), in order to receive a ballot, the person whose right to vote has been challenged must either provide satisfactory evidence to the PEO that the person is entitled to vote or make a solemn declaration before the PEO as to their entitlement to vote in accordance with the requirements set out in section 88(4).

I've read sections 87 and 88.

Section 88 seems to give polling station staff the discretion to ask for ID.

I could not find a section that states, as below, that it would be a contravention of legislation. Could you point me to the section of the law where that is? Or is that an interpretation based on case law? Again, please cite an example.

I am receiving many queries from citizens who are concerned that the lack of request for ID, as is done in other elections, leaves this by-election at risk of voter fraud.
