Hi Annie,

Sorry I missed your call, but I received your voice message regarding the client's request for a breakdown of the approximate 3 days' worth of work.

It may be worth communicating to the requestor that this sewer catch basin GIS information that they're requesting is publicly available in our Open Data Catalogue on our website (http://data.vancouver.ca/datacatalogue/index.htm), just not in the specific format they are asking for. Everything they require is available in the .shp file. But it is because they are specifically asking for an .xls file format that we would have to spend the time to convert the data and of course check the conversion for accuracy and completeness before releasing the information.

I don't specifically have the tool to complete this, so the request would require a level of coordination with either our IT department's GIS group or someone else in our department who may have the capability.

Hope this helps, let me know if there's anything else I can provide.
