I have a been a resident of Kitsilano for more than 20 years. I chose to live in Kitsilano and make this my home, because here I can walk to all the amenities that I need and am able to support local business, a life philosophy that is very important to me and to the City of Vancouver as well. I have watched Kitsilano change over the years, some for the better, some for the worse, but overall it's still a wonderful place to live.

I have, however, become increasing perturbed by the number of medical marijuana outlets that have sprung up in the neighbourhood - there are three alone in the first block and a half west of Burrard, I naven't even taken an inventory past that point. Although I'm not opposed to having one of these in the neighbourhood, I can't honestly see the justification for allowing so many of them. The City should be promoting a healthy mix of uses in the neighbourhood so that it stays vibrant and accessible to all of us who live here. How else can I leave my car at home (lets face it a major mandate of the City) if everything I need and use is disappearing. If the City keeps saying yes to every one of these applications (and there will be more) landlords will continue the upward rental trend until no one can afford to be on 4th except these high revenue producing places.

#### Dear Madam.

I am writing in response to Development Application No. DE419276 [re: Buddha Barn, 2181West 4th Ave. (second floor, 2179 W.4th Ave.) Vancouver, BC].

As long-time residents of Kitsilano

we are very strongly adverse to the Development

Application No. DE419276.

Specifically, the proximity of the proposed development of a 1807 square feet outlet on Kitsilano's main thoroughfare, adjacent to some of Kitsilano's highest housing density and close to (or part of) an already existing medical-marijuana outlet raises the following concerns and question/

- 1. It is not clear whether the proposed outlet is in addition to or an expansion of one existing in the location.
- 2. An additional or an expanded medical-marijuana outlet in the proposed location has not been quantitatively or qualitatively justified.
- 3. The proposed size of the outlet (1807 square feet) presupposes a high volume of clients/users which will inevitably exacerbate an already serious parking/traffic problems in the immediate area.
- 4. The new/expanded outlet will inevitably increase the pedestrian volume of an already congested area.
- 5. The actual smoking of marijuana in the proposed outlet and its environs will inevitably increase which, along with marijuana's unique odor, like tobacco, is not universally appreciated.
- 6. The projected size of the outlet and the resultant concentration in the Kitsilano community of marijuana-related availability and use will inevitably create a 'magnet' for other marijuana users or seekers which would seriously exacerbate the abovementioned concerns.

I have been the owner of residential property just away from the proposed development for the past 14 years. I also commonly shop with my young family on West 4<sup>th</sup> Avenue. It is with profound disgust and disappointment that I am writing to oppose the application by The Buddha Barn to establish a marijuana shop at 2181 West 4<sup>th</sup> Avenue. It should be clear to you and all other regulators at City Hall that this kind of business is not just for the purpose of selling 'medical marijuana'. It is regrettably, an apparently legal means of selling recreational drugs. And it should also be clear to you and all other regulators that promotion of marijuana at a storefront will only tempt the many vulnerable hildren and adolescents in the neighbourhood to use marijuana. First and foremost is that the possession and sale of marijuana is contrary to sections 4 and 5 of the Controlled Drug and Substances Act (CDSA). The only exception is so-called "medical marijuana" and it's only "medical marijuana" if it's distributed by mail through registered producers licensed under the Marihuana for Medical Purposes Regulations (MMPR) to persons with a physician's prescription who have registered under the MMPR. There are 18 fully authorized licensed producers and 7 licensed cultivators in Canada. A list of licensed producers is available on Health Canada's medical marijuana page here. The process for registering and obtaining your medical marijuana under the MMPR is here.

This is the only legal way that marijuana can be bought and sold in Canada. So if a retail marijuana outlet is receiving its inventory of marijuana from an authorized producer, then the producer is breaking the law by selling to the retailer, rather than to registered individuals with prescriptions through the mail. Additionally, the retailer is breaking the law because it's selling to consumers in a retail store environment when the sale should be directly between the authorized producer and the patient, again by mail.

In short, there shouldn't be a retailer at all, and there's no way a retailer can be operating a legal business without contravening section 4 or 5 of the CDSA. Period.

Why is the city even considering a change of use for the existing illegal pot shop? This establishment should have been shut down as

soon as the signs went up. We are strongly opposed to the proliferation of these shops dealing in illegal drugs and selling to the public.

This is an illegal operation open to involvement by criminals as they are not about to share this lucrative business.

Please do not grant approval of this application. We need to remove all of these illegal pot shops selling illegal drugs. Let's start with not approving this application.

- 2. At least 300 m from:
  - Schools\*
  - Community centers\*

  - · Youth facilities that serve vulnerable youth
  - Other marijuana-related businesses\*
    - \* Similar to the 1,000-foot distance required in Washington and Colorado states
- With a business licence (the licence fee is \$1,000 for compassion clubs or \$30,000 for medical marijuana-related retail dealers)
- 4. With a development permit that includes a standard community notification process
- 5. With a signed good neighbour agreement

These regulations were enacted by Council on June 24<sup>th</sup>, 2015. None of the existing stores will be grand fathered in, so we are putting them through the conditional application process as we would any business.
