

Planning/Capital Grants for Cultural Spaces

City of Vancouver Cultural Spaces Infrastructure Grants

Three programs provide support for cultural space planning, acquisition (purchase), renovation and development. Grants are eligible to Vancouver-based arts and cultural spaces operated by non-profit cultural societies, co-ops, registered charities, xʷməθkʷəy̓ əm (Musqueam Indian Band), Skwx̱ wú7mesh (Squamish Nation) and səliłwətał (TsleilWaututh Nation) or Urban Indigenous non-profit organizations.

- Small Grants for Cultural Spaces – Grants up to \$25,000 for smaller cultural space projects including, for example: space planning, research, building improvements and accessibility upgrades; and mentorships between organizations, or mentorships between organizations and professionals, to support planning, knowledge sharing and capacity building with regards to cultural spaces.
- Cultural Infrastructure Grants (CIG) – Matching Grants up to \$250,000 for capital building-based projects including space planning and research; or acquisition (purchase), renovation, or expansion of an arts and cultural facility.
- Critical Assistance Capital Grants –Ongoing Intake (subject to available funds): Grants up to \$25,000 to support urgent building life safety upgrades.

Canadian Heritage – Cultural Spaces Canada Fund

The Canada Cultural Spaces Fund (CCSF) supports the improvement of physical conditions for arts, heritage culture and creative innovation. The Fund supports renovation and construction projects, the acquisition of specialized equipment and feasibility studies related to cultural spaces.

The following organizations are eligible for funding: Non-profit arts and heritage organizations incorporated under Canada Not-for-profit Corporations Act or under the equivalent provincial or territorial legislation. Projects proposing the development and management of a creative hub. Provincial/territorial governments, a municipal administration, one of their agencies or an equivalent Indigenous peoples' institution or organization that has historically demonstrated its support to professional artistic or heritage activities, including Indigenous cultural practice in their community. Federal organizations and federal Crown corporations are not eligible for funding.

British Columbia Arts Council - Arts Infrastructure Program

The Arts Infrastructure Program enables eligible organizations to develop and enhance spaces that support the work of B.C.'s arts and cultural practitioners. The program aims to support projects that:

- Catalyze the development of new or existing arts and cultural spaces through acquisition, renovation, or purchase of specialized equipment;
- Improve physical, social, and cultural accessibility to arts and cultural spaces;
- Enhance access to arts and cultural spaces for underserved communities and underrepresented arts and cultural practices; or
- Strengthen the capacity of the sector to develop, operate, and sustain arts and cultural spaces.

Three project categories include: 1) Planning & Consultation 2) Capital Improvements 3) Specialized Equipment Acquisition.

Province of British Columbia – Gaming Grants Program – Capital Project Grants

Capital Project Grants provide \$5 million annually to not-for-profit organizations throughout B.C., to support the completion of inclusive, accessible capital projects that meet community-identified needs and priorities. Applicants must demonstrate that they have matching funds available to complete the proposed capital project.

The Arts Infrastructure Program supports B.C. First Nations, First Nations, Métis and Inuit community organizations and First Nations led non-profit arts and culture organizations and societies. Funding supports construction or renovations of art spaces, artistic production projects, administrative capacity building and operational assistance.

There are three areas of funding to choose from: 1) Organizations 2) Community Art Spaces 3) Arts Administrator Internships

The Enabling Accessibility Fund (EAF) provides funding for projects that make Canadian communities and workplaces more accessible for persons with disabilities. EAF aims to create more opportunities for persons with disabilities to take part in community activities, programs and services, or access employment.

There are three different program components in EAF. Each component holds separate calls for funding. 1) The youth innovation component 2) The Small Projects component 3) The mid-sized component.
