

POLICY DIRECTIONS

Existing Heritage Resources

- Use tools and incentives available through existing city-wide heritage policies to protect and recognize heritage resources within Marpole.

Possible Additions to the Heritage Register

- Identify heritage resources significant to the community.

Marpole Midden

- Collaborate and consult with the Musqueam First Nation to explore options for the Marpole Midden site that acknowledge its historical and cultural importance.

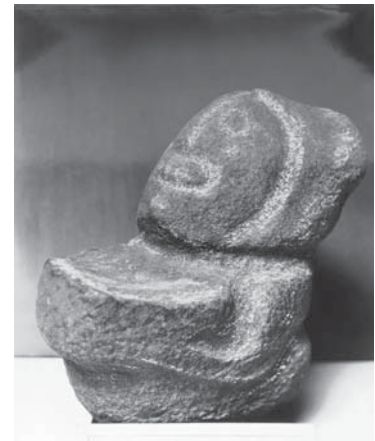
- Look for opportunities to integrate Musqueam place names, history and cultural expression into the Marpole public realm, including major words using the Musqueam lettering.



HERITAGE RESOURCES

Existing Heritage Resources

- 20 heritage buildings on the Vancouver Heritage Register. 6 are classified as A (Primary Significance), 13 are classified as B (Significant) and 1 is classified as C (Contextual or Character)
- Cairn (a stone monument) in Marpole Park commemorating the Marpole Midden
- Marpole Midden containing cultural materials and intact burials of the Musqueam people
- Hiqw Sto:lo (Big River) - the Fraser River



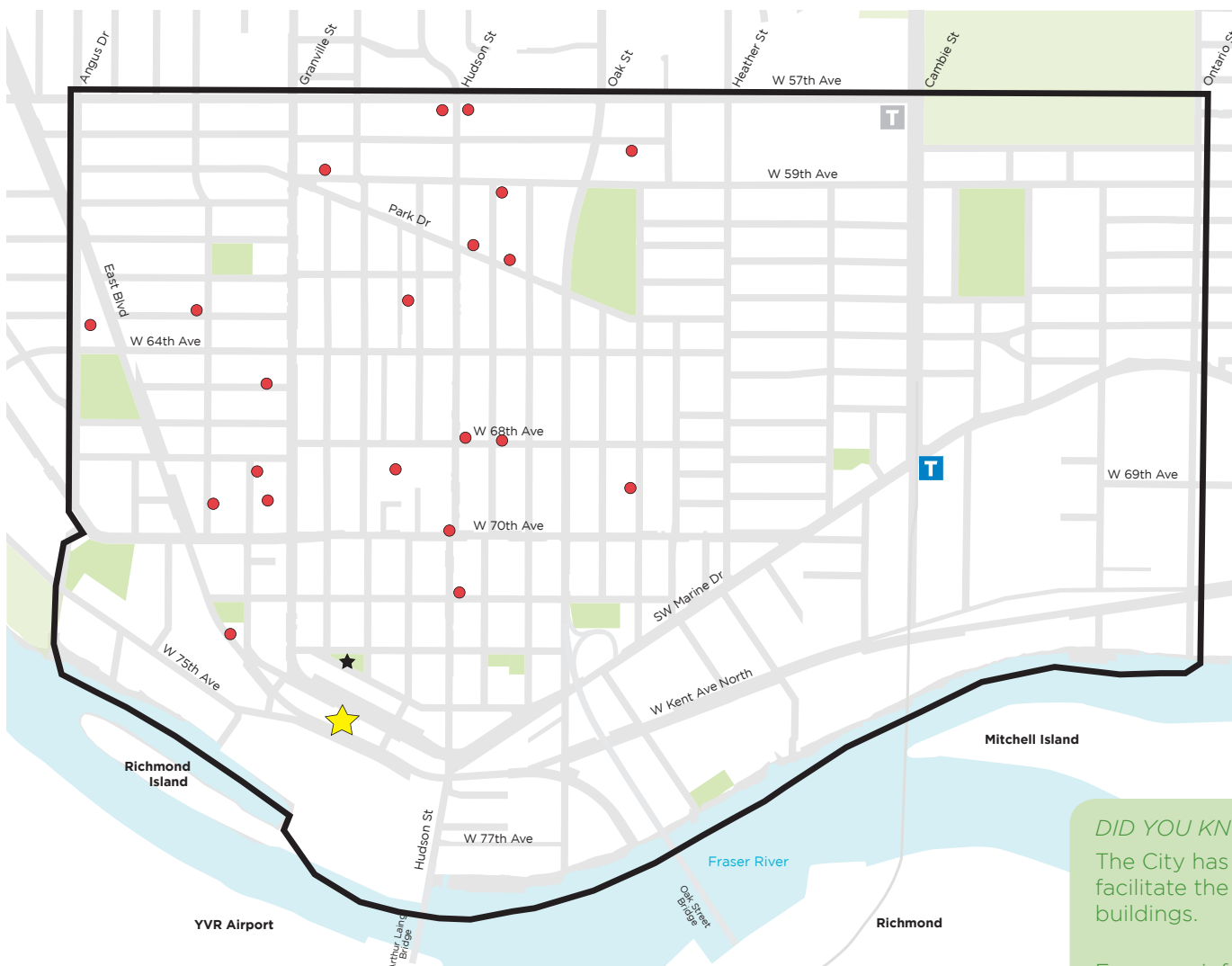
A medicine man's altar from Great Fraser River Shell Mound exhibit, 1931

POLICY DIRECTIONS

Cultural Facilities

- Develop, enhance and retain flexible public and private spaces for cultural and social activities.
- Make use of non-traditional spaces to host events and festivals.
- Where appropriate and feasible, integrate cultural space, including artist live-work studios, into residential and mixed-use buildings with a focus on Granville, Lower Hudson, and the duplex area south of SW Marine Drive.

Artist Studios

- Encourage the provision of artist studio space, in new developments, where appropriate.

Lower Hudson Street Cultural Hub

- Develop and enhance the Lower Hudson Street area into a cultural hub.
- Strongly encourage cultural uses in choice of use areas.

Co-locating Cultural and Community Space

- Look for ways for cultural and community space to be located together.

Art in Public Places

- Include art in public places that enhances the pedestrian experience and complements the area.
- New artwork should provide residents with opportunities to participate in celebratory or creative experiences in parks and streets.
- Look for ways to use art in public spaces to recognize Musqueam history, in collaboration with the Musqueam First Nation.
- Seek to interpret the cultural history of Marpole to enrich community facility developments.

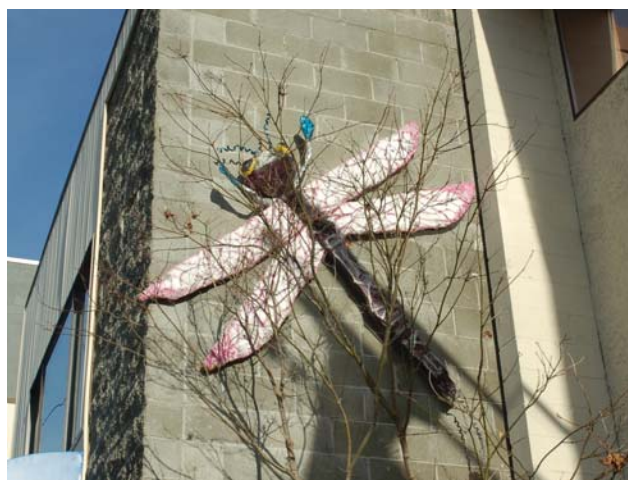
