3) 728-796 Main Street - Rezoning Enquiry

5.40PM - 7.00PM

The rezoning enquiry is being considered under the Rezoning Policy for Chinatown South (HA-1A). The proposal is for a 16-storey mixed-use development with commercial uses at grade facing Main and Union streets (5,075 sf), 18 social housing units on the second floor (9,630 sf), and market residential units from levels 3 to 16 (101,445 sf). The proposed height is 150ft and the total built area 116,150 sf (FSR 9.04). The proposed social housing is to replace existing SRA units on site and to be delivered turn-key to the City.

The development site consists of three lots:

- **728 Main** occupied by a two-storey commercial building built in 1904, was listed in category "C" on the VHR and was delisted in 1994;
- 780 Main vacant lot
- 796 Main existing three-storey SRA hotel located at the corner of Main and Union (Creekside Residence), built around 1905-1908, recently evaluated as potential "C" heritage building on the VHR, with 207 Union (at the back of 796 Main) known as "Jimi Hendrix shrine" which was never on the VHR.

It is proposed to reconstruct and incorporate the principle façade of 728 Main St. and to develop a Commemorative Plan and displays to be located in the lane next to Union St. to celebrate the Chinese and African-Canadian population in the beginning of 20th century in this area (Hogan's Alley). Applicant has conducted heritage evaluation of 796 Main St. building (SRA), as well as the Main Taxi building - 207 Union St. (aka Jimi Hendrix shrine) where no direct connection with the history of Hendrix family has been confirmed. Statement of Significance has been prepared for both buildings. Some of identified character- defining

elements were used to inform the design of the lower façade of the new building (chamfered corner, 3-storrey form and massing). No conservation of any heritage component of these two structures has been contemplated.

Applicant and staff will present the proposal and provide further information as required.

Issues: -compatibility with Design Guidelines for HA-1A and Rezoning Policy for

Chinatown South (HA-1A), in particular in regards to the scale and form of development, proposed FSR, proposed setbacks, building massing

and architectural character;

-proposed mix of uses;

-general level of proposed heritage conservation;

-Hogan's Alley Commemorative Plan (not developed yet).
