3) Pender Street Water Main Project

6.35PM - 7.30PM

The scope for this phase will include the installation of the water main along Pender Street, from Gore to Seymour. The work is expected to occur from early August of 2015 until summer of 2016. The project will be managed, designed and constructed by City forces. High level work phasing and sequencing includes starting at Carrall and moving eastwards towards Gore in 2015, and moving back to Carrall and working towards Seymour in 2016. During the project a constrained traffic movements should be expected. Crews will be working at two blocks at a time and there will be one lane eastbound open during construction. Staff will be in attendance to present the project and provide more information.
