# 2) Dr. Sun Yat-Sen Classical Chinese Garden - Jade Water Pavilion - Conservation Plan

Zlatan Jankovic, Heritage Planner provided opening comments on the item and introduced applicant Berry McGinn, McGinn Engineering and Preservation Ltd.

Mr. McGinn provided history on recent garden preservation initiatives and spoke to working with City Park's staff on a phased conservation plan for the gardens.

Mr. McGinn reviewed the conservation plan for the Jade Water Pavilion as previously distributed, noting the following:

- the plan's policy environment;
- the structure's current condition and issues of concern;
- the traditional construction processes and materials originally used, which have not proved durable enough for Vancouver's weather and seismic environment;
- the proposed rehabilitation and conservation measures.

The applicant and staff responded to various questions related to the application and the Committee provided comments on the proposed conservation plan. The Committee expressed interest in receiving more information on the Garden's overall maintenance strategy and conservation plan.

THAT the Chinatown Historic Area Planning Committee (CHAPC) supports the proposed conservation plan for the Jade Water Pavilion at the Dr. Sun Yat-Sen Classical Chinese Garden as presented.
