1) Adoption of Agenda and Minutes

2) Sign By-law Review

Staff led a review of the on-table presentation titled "Sign By-law Review - October 13, 2016", providing information on the work of City-wide & Regional Planning Branch staff to update the Sign By-law.

Commissioner Shum arrived at the meeting.

Members were referred to the Sign By-law Review webpage (http://vancouver.ca/your-government/sign-bylaw-update.aspx) for more information.

Suggestions and considerations in discussion were regarding: proactive enforcement and education; non-compliance; support for efforts to simplify the By-Law; specific provisions for signage in Chinatown; heritage conservation best practices; inability of the City to comment on content of private signage; history of signage types in Chinatown; incentives to encourage bilingual signage; sign policies in other Chinatowns in big cities; potential for the By-law to selectively allow neon near residential; LED versus neon signage; consultation process to date; evolution of lighting technology.

Inge Roecker arrived at the meeting. On her arrival, the Chair confirmed the presence of quorum.

Suggestions and considerations in further discussion were regarding: potential to address multiple real estate signs on a property through enforcement; concern regarding allowing 30% window coverage in historic areas; whether there should be an allowance for banners on historic buildings; options for construction signage that is a form of public art; interest to ensure that any window signage provides the opportunity for pedestrians to see through into the business.

THAT the Chinatown Historic Area Planning Committee (CHAPC) generally support the Sign By-Law Review with encouragement of the following considerations for Chinatown signage:

- a) Reflective of the local cultural and historic character of Chinatown
- b) Supportive of wayfinding
- c) Limited hours for illuminating signage in close proximity to residential
- d) Sufficiently flexible so as to accommodate evolving lighting technology.
