## DTES: WHAT IS A LOCAL AREA PLAN ABOUT?

- The City of Vancouver is developing a local area plan for the Downtown Eastside.
- The Downtown Eastside Local Area Plan (DTES LAP) will be developed by the City in partnership with community representatives and stakeholders and the goal is to seek consensus through a partnership among all participants using transparent and cooperative working procedures.
- City staff, in partnership with the LAPP Committee, will undertake the
  development of the local area planning program and the resulting Local Area
  Plan. The LAP will reflect community consultations, including actions that
  may be recommended during the planning process.
- City staff, under the direction of the City Manager, will provide professional
  and technical advice to the Committee and will be responsible for organizing
  the community consultation process as developed with the committee. Staff
  will prepare progress reports and the final Local Area Plan report and
  recommendations in partnership with the LAPP Committee and the
  Committee will speak to the report at City Council.
- The DTES "Local Area Planning Process" will seek to describe a desired future for the DTES and create a framework of programs, policies and plans for the City to follow to achieve the desired future.
- To do that the LAPP Committee will reach out to as much of the DTES
  community as possible to document what is important to everyone, to
  describe where things seem to be going well and not so well, what can be
  done about them, and develop programs, policies and plans to ensure the
  best future for the community.
- The DTES LAP will create a vision and plan for the neighbourhood that recognizes the community's low-income residents and focuses on ways to improve the lives of those who live, work and do businesses in the area, today and into the future.
- It is Council's priority to build and protect adequate housing to address low income, homeless and vulnerable people in the DTES community.
- The plan will include such issues as: housing, local economic development, urban health, heritage, art, culture, places, spaces and buildings.
- Many and diverse voices are needed to make this process and plan a success.
