NEW BUSINESS

New St. Paul's Hospital – Development Concepts Workshop

- Good investment of time. Very diverse group. Project date 2023
- False Creek flats master plan. Prior will become a residential street. No decision from Council if Malkin or National would be a thoroughfare staff has recommended Malkin. No plan for high traffic access to ER. Traffic plan follow Surrey's traffic management plan. In an emergency how would you transport someone from the West end?
- On large building 8-10 stories or 15 storey building with all parking underground. On site hotel?. Scope of the building. Emergency Room, Mental Health facility fixed project. Hospice/Palliative Care would have a separate entrance. No accommodation for urgent care in the new facility would be the responsibility of Vancouver Coastal Health. Residence or facility for First Responders private time to decompress. Design concerns that have yet to be worked out. VHG would remain as the major trauma centre.
- Public consultation in the upcoming weeks.

Fire Hall 30 year Study

- Looking at the next 15 years. Possibility of Fire Halls 1 and 2 being amalgamated
- New Hall #23 45th and Main Street as there is a 'gap' in that area.
- Rebuild Fire Halls #8, #9, #6

Assistant Chiefs Hiring Process

- This should be in place at the end of September
- 4 have accepted the offer

Coastal Response Port Alberni

- Earthquake simulation. 70 HUSAR members of all levels and 200 volunteers participated. Excellent exercise. Worked 48 hours on 15 different scenarios.

Fire Boat #2

Has been sent back for repairs to Ontario of minor mishap
