**1. (a) Sustainable City of Sustainable Neighbourhoods Project
July 11, 2011**

Eileen Keenan, Chair, Vancouver City Planning Commission - Sustainable Neighbourhoods Committee, presented the report and responded to questions.

The Committee heard from two speakers, one who spoke in support of the report and one who spoke in general support but highlighted concerns in relation to the public consultation process.

Council received the Vancouver City Planning Commission's Report dated July 11, 2011, entitled "Sustainable City of Sustainable Neighbourhoods Project" for information.

**(b) Vancouver's Next Community Plans
July 15, 2011**

Staff from Community Planning presented the report and, along with staff from Planning, responded to questions.

The Committee heard from eight speakers, three who spoke in general support of the report and five who spoke in opposition and expressed concerns in relation to the community planning process.

- A. THAT Council endorse the approach outlined in the Administrative Report dated July 15, 2011, entitled "Vancouver's Next Community Plans", to guide planning in the next Community Plan neighbourhoods.
- B. THAT Council direct staff to begin Community Plan programs in Grandview-Woodland, Marpole and the West End;

FURTHER THAT Council approve the additional funding necessary to undertake all three plans concurrently, as outlined in the Financial Implications section of the Administrative Report dated July 15, 2011, entitled "Vancouver's Next Community Plans", and detailed in Appendix C of that report, subject to the 2012 budget process.

- C. THAT Council approve the rezoning policy attached in Appendix B of the Administrative Report dated July 15, 2011, entitled "Vancouver's Next Community Plans", to establish the conditions under which new rezonings and heritage revitalisation agreements will be considered while the Grandview Woodland, Marpole and West End Community Plan programs are underway.
- D. THAT Council direct staff, as part of the city-wide plan scoping process, to report to Council on a plan to building neighbourhood capacity such that all neighbourhoods can effectively participate in the planning process; and that interim to the above-referenced report, staff undertake actions to increase capacity as opportunities allow.
- E. THAT interim to the city-wide planning process concluding the following enhancements to the rezoning process be implemented as interim measures:
 - (i) A liaison Councillor and alternate be appointed to each Vision Implementation Committee;
 - (ii) Staff identify and publish a list of all areas, building types and issues within the existing Visions which were identified as needing further planning and that staff encourage development proposals that relate to these, to be brought to the early attention of the Vision Implementation Committees in order that they can be more meaningfully involved in early planning in such circumstances; and
 - (iii) The notification area for proposed rezonings be expanded on a case by case basis to include an area that would be reasonably impacted by a proposed rezoning (e.g. - Impacts from shadowing, views, traffic, etc).

**2. Downtown Separated Bicycle Lanes Status Report, Summer 2011
July 20, 2011**

MOVED by Councillor Meggs
THAT the Committee recommend to Council

- A. THAT Council receive the Administrative Report dated July 20, 2011, entitled "Downtown Separated Bicycle Lanes Status Report, Summer 2011", for information.
- B. THAT staff report back in 2012 after at least twelve months of trial monitoring data is available on both the Dunsmuir Street and Hornby Street separated bike lanes.
- C. THAT both the Dunsmuir Street and Hornby Street separated bike lanes stay in place until staff report back, and that staff continue to refine configuration and operation of the lanes, including intersection operations.
- D. THAT Council approve the use of bicycle signals on bicycle facilities in the City of Vancouver, where considered appropriate by the City Engineer.

**3. Business Impact Study Report, Downtown Separated Bicycle Lanes
July 20, 2011**

Lee Malleau, CEO, Vancouver Economic Development Commission, presented the report.

The Committee heard from seven speakers, one who spoke in support of the report and provided general comments on the advantages of separated bicycle lanes, and six who spoke in general support but expressed concerns in relation to negative impacts on businesses associated with the separated bicycle lanes, and stressed the need to align the report recommendations more closely with those of the consultant's report.

MOVED by Mayor Robertson

THAT the Committee recommend to Council

- A. THAT Council receive the preliminary Business Impact Study Report (the Study) outlined in Administrative Report dated July 20, 2011, entitled "Business Impact Study Report, Downtown Separated Bicycle Lanes", for information.
- B. THAT Council direct City staff to consider the Study recommendations with regard to 'hot spots,' with particular focus on implementing a trial of right turn signals at Dunsmuir and Seymour and Dunsmuir and Hornby intersections, and to continue working with businesses on Hornby and Dunsmuir Streets, and for staff to provide a memorandum to Council in October 2011, on further steps to be taken to continue improving the separated bike lane experiences on those streets as well as a report back to Council in 2012.
- C. THAT Council direct City staff to take into account the Study recommendations in its ongoing work in development of the new City Transportation Plan.
- D. THAT the Vancouver Economic Development Commission (VEDC) work with City staff and stakeholders to report back with an assessment of economic impacts once two (2) or more years of demonstrable retail lease rates and sales data is more available.
