### **OLD BUSINESS:**

- Vancouver Fire Foundation
  - Constitution Bylaw ready for filing with the New Society's Act.
  - Would need to schedule an AGM transition to the New Society's Act
  - Move forward with appointing a new Director (replace former City Manager)

#### Committee Mandate & Activities Sub-committee

#### **NEW BUSINESS:**

- Deputy Chief's Report
  - Union Local 18 contract was ratified today 4 year contract to January 2019;
     2.5% over the next four years; fully paid Officer Development Program; 15 year rate 106% specialty teams; promotional language; Munroe agreement null and void; BC's moved to Exempt AC rank; staffing pool more flexibility; overtime, benefits; 19 grievances were resolved due to this CA; Notice Item issues taken off.
  - Provided an update on apparatus, firehalls and fireboats.
  - Budget 1.9 million dollars opioid crisis, staffing at Fire Hall #2, 16 more staff.
  - Real Estate Management Group 30 year Relocation Plan.
- Explore the possibility of VF&RS working with Senior Centers Anthony
  - Fire in apartment response
  - Accessing injured Seniors
  - CoV's Seniors Advisory Committee
  - Assisting isolated seniors safety in homes
  - Senior Services Society New Westminster
  - Deputy Chief liaison for Seniors' issues smoke detectors, safety checks etc.
  - Catalogue; inspections, wheelchair assistance included in the CAD system, rescue. Develop a tool that is self-managed include all this information on this vulnerable group- Police/Fire/Ambulance information not shared due to privacy issues. Safety of first responders. Information needs to be updated regularly and vetted out periodically. VF&RS staff responding would have this information.
  - Emergency Alerts: chemicals, weapons, hazardous materials etc.
  - High concentration of seniors electronic management system; tailor the resources. Reduce calls – social isolation, medical condition
  - Motion to form a sub-committee to explore this further was proposed, seconded and unanimously carried. Anthony, Ross and Daniel will form this committee.

#### **OTHER BUSINESS:**

- Resilient CoV Daniel will provide an overview at the April meeting
- Flag Day 60' flag pole erected. Press release. Next year this event will be held in the east side of Vancouver.
- Smoke Detectors different vendors, donations. DC Moore to check with the Fire Life Safety division and provide list of suppliers
