

## **District 1**

District One includes the neighbourhoods of the West End, Yaletown, Coal Harbour and the Central Business District of Vancouver.

## **District 2**

District Two includes the neighbourhoods of Strathcona, Grandview/Woodlands and Hastings/Sunrise.

## **District 3**

District Three is the South East quadrant of the City, which includes Mt. Pleasant, Kensington/Cedar Cottage, Renfrew/Collingwood, Sunset, Victoria/Fraserview and Killarney.

## **District 4**

District Four is the largest of the Patrol Districts encompassing the communities of Kitsilano, Marpole, Shaughnessy, Kerrisdale, Riley Park, Dunbar, Oakridge, Arbutus Ridge, South Cambie, Fairview and Musqueam. This area comprises 48% of the geographic area of Vancouver
