

# 2017-2018 Work Plan Urban Indigenous Peoples' Advisory Committee

### Mandate

### Policy Advice

- Provide input to City Council and city staff about issues of concern.
- Consider any matters which may be referred to the Committee by Council or staff.
- May take positions on policy initiatives from other levels of government within the mandate of the Committee.

### Collaboration

- Work co-operatively with other agencies whose activities affect constituent communities, including initiating and developing relevant projects.
- Act as a resource for staff doing public involvement processes and/or civic events.

### Awareness & Outreach

- Exchange information with the constituent communities and the general public about relevant programs and issues of interest.
- Engage in outreach to disseminate information and encourage participation from constituent communities.

Urban Indigenous Peoples

- Advise Council and staff on enhancing access and inclusion for urban Indigenous peoples to fully participate in City services and civic life.
- Advise Council and staff on the City of Reconciliation Framework as it is developed, implemented and updated.

## 2017-2018 Objectives

### **Objective 1:** Civic Engagement

Work with city staff to increase voter turnout from the urban Indigenous community.

### Objective 2: MMIWG Inquiry

Engage with the community, and find ways for the City to support families and survivors during the MMIWG Inquiry in Vancouver. Support outreach activities, and act as a resource for staff.



#### **Objective 3:** Project Engagement

Participate in City projects that call for engagement with the urban Indigenous community. Provide advice on options and directions. Act as a resource for staff.

**Objective 4:** Engagement with other Civic Advisory Committees

Participate in City projects that call for engagement with the urban Indigenous community. Provide advice on options and directions. Act as a resource for staff.

**Objective 5:** Standardize 'Indigenous' Name change to Urban Indigenous People Advisory Committee & standardize Indigenous throughout City
