**1. Street Naming Request from Staff**

- a. Pearson Dogwood development

WHEREAS

1. On July 24, 2018, Vancouver City Council adopted a resolution to name the new public street between Cambie Street and Heather Street, running south from West 57th Avenue to the extension of West 58th Avenue, "Markovich Street";
2. On January 21, 2020, Vancouver City Council did not enact the by-law required to name "Markovich Street" and referred the item back to the Civic Asset Naming Committee for further consultation;
3. Jeanette Andersen was a long-time resident of Pearson hospital and a champion for persons living with disabilities; and
4. The Markovich name can be used to name a street in the new Langara Gardens Development.

THEREFORE BE IT RESOLVED THAT the Civic Asset Naming Committee recommend to Council that the public street between Cambie Street and Heather Street, running south from West 57th Avenue to the extension of West 58th Avenue, be named "Jeanette Street", and that "Jeanette Andersen" be added to the reserved section of the Civic Asset Name Reserve List.

FURTHER THAT the public street running from West 54<sup>th</sup> Avenue to West 57<sup>th</sup> Avenue, currently a private street called Ash Crescent, in the Langara Gardens development be named "Markovich Street", and the entry for "Leonora Markovich" on the Civic Asset Name Reserve List be amended to reflect this location.
