# 1. Street Naming Requests from Staff

#### a. Plaza of Nations site

The Co-Chair, John Atkin, introduced the item and the Committee engaged in discussion. Following the discussion, the Committee agreed that additional information is required and that further discussion will take place at a future meeting.

### b. Tag Lines for recently approved street names

The Co-Chair, John Atkin, introduced the item and the Committee engaged in discussion considering tag lines for the recently approved street names:

- i. New St. Paul's Hospital site
- ii. Oak Green site
- iii. River District site
- iv. Plaza of Nations site deferred
- v. Pearson Dogwood site

THAT the Civic Asset Naming Committee recommend to Council the following:

- A. THAT the tag line for the New St. Paul's Hospital site, Nora Hendrix Way be "AME Fountain Chapel co-founder | Black community organizer".
- B. THAT the tag line for Oak Green site, Nemetz Drive, be "An immigrant family of eleven who became community builders";
  - FURTHER THAT the tag line for Oak Green site, Collins Street, be "Frank Collins | Barrier-breaking Black bus driver | Civil rights & union organizer".
- C. THAT the tag line for River District site, Bulrush Avenue, be "Water-purifying wetland plant used for weaving by Indigenous peoples".
- D. THAT the tag line for Pearson Dogwood site, Jeanette Street, be "Jeanette Andersen | George Pearson Centre resident | disability advocate".

### 2. Liaison Updates

The Council Liaisons advised the Committee that the 2021 Capital and Operating Budget was approved and that the City is currently in the process of hiring a new City Manager.

The Council Liaisons also provided an update on the feedback received from City staff regarding the Committee's request for a process to consult with Musqueam, Squamish and Tsleil-Waututh Nations regarding street naming suggestions and opportunities.

The Council Liaisons further advised the Committee that there is a forthcoming member's motion that is anticipated to be put forward at the Council meeting on February 9, 2021, relating to the Komagata Maru.

#### 3. New Business

### a) Commemorative Naming Policy

Following the updates provided by the Council Liaisons, specifically the forthcoming member's motion anticipated at the Council meeting on February 9, 2021, the Committee engaged in discussion about the *Commemorative Naming Policy*.

#### WHEREAS

- 1. There is not yet a policy in place for equitably determining who is approved for secondary commemorative naming; and
- 2. Emergency Response staff may have unresolved questions regarding the safety of secondary commemorative naming.

THEREFORE BE IT RESOLVED THAT the Civic Asset Naming Committee eagerly awaits the finalization of the City's *Commemorative Naming Policy*, so that the Committee can open up new opportunities of assets to move forward the City's commemoration work:

FURTHER THAT the Civic Asset Naming Committee recommend to Council that any commemorative naming requests for secondary or supplemental signage and names be postponed until after the *Commemorative Naming Policy* is in place.

#### CARRIED UNANIMOUSLY

Following the approval of the above-noted motion regarding the *Commemorative Naming Policy*, Council Liaisons agreed to inform the Council member intending to bring forward the motion relating to the Komagata Maru, of the Committee's feedback and decision.

### b) 86 SE Marine Drive and 101 East 69th Avenue – Old Dueck Site

The Assistant City Surveyor introduced the rezoning application at the old Dueck site located at 86 SE Marine Drive and 101 East 69th Avenue, and that naming requests will be introduced at a future meeting for the Committee's consideration.
