# 1. Guest Welcoming and Introductions

The meeting commenced with roundtable introductions of Committee members and staff.

Anne Nickerson, Director, Equal Employment Opportunity Program, provided an update on the Trans\*, Gender Variant and Two-Spirit Inclusion Recommendations and sub-recommendations, and responded to questions. Ms. Nickerson is looking at expanded gender categories and seeking feedback from the Committee. More information will follow via email.

# 2. Staff and Liaison Updates

Constable Dale Quiring, Vancouver Police Liaison, provided an update on ongoing work including SOGI issues outside Vancouver, training requests from outside the Lower Mainland, collecting data on gender, and spending more time at Jim Deva Plaza in the coming months.

Kiran Marohn, Assistant Chief, Recruitment/Outreach, Vancouver Fire and Rescue Services, provided an update on training first responders, bathroom signage and following up on the gender question on various recruitment forms that are currently used.

### 3. Rainbow Crosswalk Motion

MOVED by Rob McDowell SECONDED by Sylvia Machat

#### WHEREAS:

- As identified in Trans\*, Gender Variant and Two-Spirit Inclusion at the City of Vancouver Report (2016) and by Saewyc, Poon, Kovaleva, Tourand, & Smith (2016), LGBTQ2S+ people in BC experience significantly higher rates of bullying, harassment and suicide than other populations, and the lack of visible representations of LGBTQ2S+ people in the broader community exacerbates these harms;
- Vancouver has taken a leadership role in protecting LGBTQ2S+ people in our city. Several local governments in British Columbia are being asked to increase visible representation of the LGBTQ2S+ community by installing rainbow crosswalks and are unsure how to proceed. Standardized guidelines on implementing such projects do not yet exist in BC.

THEREFORE BE IT RESOLVED THAT the LGBTQ2+ Advisory Committee recommends that Council put forward the following motion at the Union of BC Municipalities meeting in 2018:

"RAINBOW CROSSWALKS"

#### WHEREAS

- LGBTQ2S+ people in British Columbia experience significantly higher rates of bullying, harassment and suicide than other populations and a lack of visible representation of LGBTQ2S+ community exacerbates these harms;
- A number of local governments in BC are being asked to increase visible representation of the LGBTQ2S+ community through the installation of rainbow crosswalks and would benefit from standardized guidelines on how to implement such projects:

THEREFORE BE IT RESOLVED THAT the Government of British Columbia be requested to inform and advise local governments on best practices to handle such requests, and to provide financial and technical support to local governments regarding visual representations of the LGBTQ2S+ community, such as rainbow crosswalks.

# 4. Subcommittee Updates

### a) Reconciliation Subcommittee

Chase Willier provided an update from the April Reconciliation Subcommittee meeting. At the meeting it was decided the Subcommittee would proceed with planning for an event of a social-cultural nature and commence work to bring the Two-Spirit community together. This event will be the start of a respectful relationship with the Two-Spirit community and open the door for engagement in the future. The Reconciliation Subcommittee submitted a proposal for funds of up to \$9500 under the Great Beginnings initiative at the City and noted additional funds from Parks may be contributed as well.

The proposed event will honour the Two-Spirit community in a cultural way which would include a feast, drum groups, elders and honouring the past and present of the Two-Spirit community and lay the groundwork for future work with the City of Vancouver. The role of the Reconciliation Subcommittee is to open the door, to prepare and assist, and support the City in their own work in engagement with the Two-Spirit community.

#### 5. New Business

### a) Year of the Queer Proclamation and Launch

Brendan Bailey informed the Committee of a report entitled, "Year of the Queer Proclamation and Launch" going forward at the Regular Council meeting to be held on May 15, 2018. Once approved, an event will take place on May 23, 2018, both in Council Chamber and outside at the Helena Gutteridge Plaza.

### b) Idea Jam on the Empty Homes Tax

Jutta Kohli reminded the Committee of an invitation to Idea Jam on the Empty Homes Tax taking place on May 17, 2018, from 10 am to 3 pm at CityLab (511 West Broadway).

## c) Whatever Pool Party

Paul Czene, Staff Liaison, informed the Committee of an upcoming event, "Whatever Pool Party" on May 26, 2018, from 10:30 pm to 12 am at the West Vancouver Aquatic Centre (2121 Marine Drive, West Vancouver). It is an all-bodies swim for LGBTQ+ youth and their allies aged 13 to 18. The "Whatever Pool Party" is being hosted by West Vancouver's Aquatics, Youth Services and the 'Whatever' Youth Committee and is open to youth from across the North Shore, the Sea-to-Sky corridor and around the Lower Mainland.
