2. Staff Presentation - Davie Street - Transportation and Public Space

Staff from Engineering Services provided a presentation on Davie Street - Transportation and Public Space and responded to questions and comments from Committee members.

Committee members discussed the need for the following:

- ensuring that Davie Village is a focus of the City's place-making initiatives;
- keeping the Village active after St. Paul's Hospital is relocated;
- improving the visual expression of the Village (e.g., creative lighting, multilingual signage, easy-to-read historical markers, and artwork by 2SLGBTQ+ residents);
- encouraging businesses and organizations to activate their street-fronts;
- adding comfortable and inviting street furniture that is protected from the elements;
- expanding the range of affordable events, meeting spaces, and social venues to appeal to more diverse communities, including new immigrants;
- holding more pop-up events (e.g., queer book exchanges);
- ensuring that people with intersecting identities are more actively consulted about the future of the Village.

Staff from Arts, Culture, and Community Services provided a presentation on TGD2S+ Housing and Services and responded to questions and comments from Committee members.

- the need for consultation with representatives of diverse immigrant communities and asylum seekers (e.g., Rainbow Refugee);
- ensuring safety for transgender individuals with precarious immigration status;
- addressing barriers such as language issues, accessibility, and childcare;
- ensuring transgender individuals have more opportunities for leadership positions within housing and social service organizations.
