Approval of Minutes

At this point in the proceedings, the following was put on the floor:

THAT the following notes from the July 20, 2023, 2SLGBTQ+ Advisory Committee, be added to the record:

Staff Presentation: West End Commercial Streets—Davie Village

Committee members discussed the need for the following:

- ensuring that Davie Village is a focus of the City's place-making initiatives
- keeping the Village active after St. Paul's Hospital is relocated
- improving the visual expression of the Village (e.g., creative lighting, multilingual signage, easy-to-read historical markers, and artwork by 2SLGBTQ+ residents)
- encouraging businesses and organizations to activate their street-fronts
- adding comfortable and inviting street furniture that is protected from the elements
- expanding the range of affordable events, meeting spaces, and social venues to appeal to more diverse communities, including new immigrants
- holding more pop-up events (e.g., queer book exchanges)
- ensuring that people with intersecting identities are more actively consulted about the future of the Village.

Staff Presentation: TGD2S+ Housing and Services

Committee members discussed the following:

- the need for consultation with representatives of diverse immigrant communities and asylum seekers (e.g., Rainbow Refugee)
- ensuring safety for transgender individuals with precarious immigration status
- addressing barriers such as language issues, accessibility, and childcare
- ensuring transgender individuals have more opportunities for leadership positions within housing and social service organizations;

FURTHER THAT the 2SLGBTQ+ Advisory Committee approve the Minutes from the meeting of Thursday, July 20, 2023, as amended.

WHEREAS

- 1. Each Advisory Committee is established by Council to provide input on issues arising from the Committee's mandate;
- 2. Advisory Committees deliberate extensively on issues deemed important by their constituents:
- 3. Historically, presentations to Council by a single advisory committee representative have been allotted five minutes to the speaker with additional times for Councillors to ask questions; and
- 4. Historically, presentations to Council by groups with four or more members in attendance have been allotted eight minutes to speak, with additional time for Councillors to ask clarification questions.

THEREFORE BE IT RESOLVED THAT the 2SLGBTQ+ Advisory Committee ask Council to consider allotting five minutes for each Advisory Committee when a single member is in attendance to present at Council meetings and Standing Committee meetings;

FURTHER THAT the 2SLGBTQ+ Advisory Committee ask Council to consider allotting eight minutes for each Advisory Committee with four members in attendance to present at Council meetings and Standing Committee meetings;

AND FURTHER THAT Council consider allowing up to 10 additional minutes for Councillors to ask clarification questions of the Committee's speaker.

THAT the City of Vancouver's 2SLGBTQ+ Advisory Committee request that External Liaisons from the Vancouver Park Board, Vancouver Public Library, Vancouver School Board, and Vancouver Police Department be invited to engage in any or all of the following:

- a. act as a point of contact for the Committee when seeking information;
- b. provide email updates on matters that may be relevant to the Committee;
- c. attend and participate in meetings virtually or in-person.

- Aging and Housing (prospective topics: intergenerational programming; social isolation and loneliness; age-friendly recreational spaces; seniors-specific housing; inclusive housing checklist; advancing recommendations from TGD2S+ Housing Report; assisting new Seniors Planner with mandate);
- Safety and Well-Being (prospective topics: safety in public spaces; UN Safe Spaces Initiative; safety-related infrastructure; inclusive services and housing for sex workers; people living with HIV; people at risk for interpersonal violence; supporting vulnerable residents during climate-related emergencies like heat domes);
- 3. 2SLGBTQ+ Spaces and Place-Making (prospective topics: preserving cultural and historical spaces; revitalizing Davie Village and other 2SLGBTQ+ areas; encouraging 2SLGBTQ+ public art; supporting queer businesses; reviewing Park

Board procurement policy; working with Greater Vancouver Board of Trade, West End Business Improvement Association, and other business associations to create and improve 2SLGBTQ+ spaces).
