## Appendix A

#### Draft Supplementary Notes from City of Vancouver 2SLGBTQ+ Advisory Committee Meeting: March 7, 2024

#### Discussion with Anthony Kupferschmidt, New Strategic Lead for Older Persons

- Anthony will be working in Business Planning and Support in the City Manager's office
- Will be doing systems-level work in the following domains: an age-equitable city; housing; transportation; social connection; civic engagement
- Role is separate from that of social policy planners
- Intends to work across city departments
- Mentioned that Vancouver is committed to an Age-Equitable Action Plan focusing on recommendations from the World Health Organization Global Age-Friendly Cities guidelines
- This plan will extend the work of the City's previous Age-Friendly Action Plan
- Eddy Elmer asked if Vancouver ever submitted paperwork to seek designation as a Global Age-Friendly City; Anthony is unaware if anything was ever submitted; however, he did note that Vancouver received designation as an "Age-Friendly Community" through the Province, but this is not a strong designation (i.e., it simply states that a City intends to become more age-friendly)

# Discussion with Marc White and Susan Scott Gabe of the City of Vancouver Older Persons and Elders Advisory Committee (OPEAC)

#### Introduction

• Noted that many of our advisory bodies have constituents who are seniors

#### Inclusive Housing

- OPEAC does not see housing in isolation; they consider it part of a healthy city
- Mentioned that, historically, seniors have not specifically been referenced in our housing plans
- Rick Hurlbut mentioned that he is in favour of a queer-inclusive housing strategy, but would be much more supportive of a queer-*led* housing strategy; EDI can only go so far; we need leadership from identifiable communities to ensure that their needs are built into housing strategies; Marc White noted that this sentiment came out loud and clear during planning of the <u>Seattle Pride Place</u> project
- Chris Morrissey noted there are many different subpopulations within the queer community; plans for queer-specific housing have never been clear about who the housing would be for and what kind it would be; for example, housing needs and desires may differ between men and women, or homeless and non-homeless people; Eric Bethelet noted that Living with Pride Society will be conducting focus groups to understand these differences in more detail
- OPEAC has a special task force on non-profit housing philanthropy; will meet with Eric Berthelet, member of our Committee's Age and Housing Subcommittee, to discuss further

- Ilaine Marjoribanks noted that we must address discrimination in assisted living and residential care; current policy is first-come, first-served, so no queer or trans-specific housing for those who need specialized housing services
- Ilaine also noted that many queers seniors have chosen family (i.e., non-kin); they are not considered legal family members, so queer people may be accused of over-crowding if they choose to live with them; they can try to claim one person as a partner, but cannot claim others
- Marc White said it is important to consider intergenerational housing for queer people
- Ilaine Marjoribanks noted there is also discrimination in co-op housing (e.g., strata councils not accommodating people who need bed lifts)
- Persons with Disabilities Advisory Committee may be interested in 2SLGBTQ+ housing given the higher rates of disability among queer people
- Eddy Elmer mentioned the importance of knowing how many queer seniors are in Vancouver and which neighbourhoods have larger proportions; he suggested that the City look into current census data or geo-mapping technologies to find out; SPARC BC may be a good starting point; it was also suggested that Eddy contact Peter Marriot at the City of Vancouver
- March 13: <u>motion</u> going to Council re: False Creek South; OPEAC suggests that our Committee speak to the motion

#### Social Isolation and Loneliness

- OPEAC has looked closely at Eddy Elmer's report on <u>Social Isolation and Loneliness</u> and intends to prioritize the various recommendations
- Looking to address the issue from a municipal, provincial, and pan-Canadian perspective
- Did a jurisdictional scan last term to see what other cities are doing; had specific questions regarding Diversity, Equity, and Inclusion, which will they discuss with our Committee at a later date
- Looking to work with health authorities and other advisory bodies to ensure that social isolation and loneliness are integrated with their work

#### Other Focus Areas

• Age-friendly business codes

#### Seniors Housing Strategy

- City staff provided an update and took questions on the draft Strategy, which is planned for release mid-April
- Eddy asked if the Strategy considers NORCs ("naturally occurring retirement communities"); <u>OASIS</u> in Kingston, Ontario has been starting and evaluating NORCs across Canada; they currently have two in Vancouver, with two more planned
- Staff indicated that NORCs will be part of the Strategy
- Anthony Kupferschmidt also mentioned programs like Closer to Home (run by West End Seniors Network), in which staff from seniors' centres visit apartment buildings or neighbourhoods with large proportions of seniors and provide services right on site
- Eddy underscored the importance of architectural design features to facilitate social interaction; he suggested that Vancouver look into the <u>City of North Vancouver's policies</u> in this regard as well as the City's own review of sociable design features, which was part of the early work on the <u>Hey Neighbour initiative</u>

- Staff noted that <u>Happy Cities</u> is doing work on sociable design, which is informing the Seniors Housing Strategy; they are also trying to harmonize the Building By-law with provincial changes, notably around accessibility and adaptability; this will include features like broad hallways, where a lot of social interaction occurs; work is also underway on City-wide design guidelines
- Committee members also suggested that the City advocate to the Province re: culturally appropriate services and reducing discrimination in residential care and assisted living
- Ilaine asked if there are plans for an equitable housing strategy that targets the queer community, and for organizations to provide a more diverse range of housing, perhaps in partnership with more experienced agencies that specialize in assisted living and complex care
- Staff noted that they are working with community groups to solidify the City's plans for assisting older people who are homeless or at risk for homelessness; also looking to work with BC Housing on supportive housing for seniors; may also explore seniors-only shelters
- A lot of this work follows the Vancouver Plan; staff have tried to look at the data on at-risk seniors; they are prioritizing non-market housing to meet the greatest needs
- Ilaine suggested that staff contact April Sumpter-Freitag for further guidance on queer seniors' housing
- Chris Morrissey said that providing diversity training for staff in residential care is not sufficient because it often glosses over queer people's rich cultural heritage
- She also noted that many seniors do not know how to access SAFER (<u>Shelter Aid for</u> <u>Elderly Residents</u>); perhaps the City could help with this.
