# 3. City of Vancouver Budget Cuts

Following discussion, the resolution below was put on the floor:

### WHEREAS

- A. The City of Vancouver has established grants and other funding for arts and cultural organisations, and for groups which produce important community events, including those for and by the Vancouver 2SLGBTQ+ community;
- B. At the Vancouver City Council meeting of July 9, 2025, Mayor and Council pledged to find ways to financially support the Vancouver Pride Society at a time when it has seen a substantial shortfall in corporate sponsorships;
- C. The Vancouver Department of Parks and Recreation delivers programming specific to 2SLGBTQ+ individuals—programs not offered by Community Centre Associations;
- D. The Vancouver Department of Parks and Recreation receives a substantial contribution from City Council toward its operating budget—contributions that will be effectively decreased under the proposed City Council 2026 budget; and
- E. The *Proposed 2026 Operating and Capital Budget* puts at risk funding for all of these essential services.

THEREFORE BE IT RESOLVED THAT the 2SLGBTQ+ Advisory Committee requests that Council does not implement any budget cuts, freezes, or reallocations that result in a reduction to the current funding levels for programs, grants, organizations, strategies, or other financial support that promotes the wellbeing of Vancouver's 2SLGBTQ+ communities.

## APPROVED BY CONSENSUS

The Committee further agreed by consensus that if there are future opportunities to speak to Council about the 2026 budget, Rick Hurlbut and any other members be authorized to speak on behalf of the Committee.

The Committee discussed an update on a joint engagement for advisory committees that took place November 3, 2025.

# City of Vancouver 2SLGBTQ+ Advisory Committee

October 6, 2025

To: Vancouver Board of Parks and Recreation

Re: "Harry Potter: A Forbidden Forest Experience"

The 2SLGBTQ+ Advisory Committee provides advice to Vancouver City Council and staff on issues impacting lesbian, gay, bisexual, transgender, queer, Two-Spirit, and other gender- and sexually diverse communities in Vancouver. Our mandate includes identifying barriers to full participation in civic life and recommending actions to ensure equitable access to City services and programs. We also work collaboratively with counterparts from other civic agencies to identify opportunities for joint action on issues of mutual interest.

Vancouver's parks are vital public spaces that foster recreation, community connection, and cultural engagement. However, sexual and gender minorities— especially transgender, Two-Spirit, and racialized members of our communities—have historically experienced exclusion, discomfort, and targeted harassment in public and recreational spaces. Unfortunately, these experiences remain a reality for many.

2SLGBTQ+ community members have brought to our attention various concerns about the Park Board's decision to commission an event centered on the work of J.K. Rowling. As many of you may be aware, Rowling's widely publicized comments about transgender people have caused significant distress for many transgender and non-binary individuals globally, including here in Vancouver.

Although the Park Board has taken important steps toward transgender inclusion—as outlined in the <u>report</u> from the Trans\* and Gender Variant Inclusion Working Group—many in our community tell us they remain deeply concerned that the Board is giving a platform to a high-profile figure they feel has consistently amplified negative messages about transgender individuals.

While we recognize that the broader public may not be fully aware of J.K. Rowling's views and actions on this issue, the decision to feature her work in a publicly funded event risks overlooking or minimizing the lived experiences and concerns of many transgender residents in our city. Community members have also expressed concern that a portion of the event's proceeds could contribute to Rowling's ongoing legal proceedings related to transgender issues.

Although unintended, hosting this event sends a message that conflicts with Vancouver's stated values of inclusion, safety, and respect for all communities. As an open and affirming city, we expect public bodies like the Park Board to uphold and reflect these values in their programming.

We recognize that contractual commitments may limit the ability to make changes to this specific event. However, the Park Board still has an opportunity to affirm its commitment to equity and inclusion moving forward. We therefore submit the following recommendations:

- 1. Publicly acknowledge the concerns raised by 2SLGBTQ+ communities in relation to this event.
- 2. As a gesture of goodwill, consider directing a portion of the proceeds from the event to 2SLGBTQ+ community programming, in consultation with stakeholders.
- 3. Commit to more frequent and inclusive consultation processes for future cultural and recreational programming, including any repeat of this event.
- 4. Engage relevant advisory bodies as early as possible—including the Park Board's Trans\* and Gender Variant Implementation Steering Committee and our own committee—during the planning stages of future events. Early engagement will allow advisory bodies to provide feedback on similar events, helping to identify and mitigate potential risks to community members, the City, and the Park Board.
- 5. Implement equity-based impact assessments for all future programming and events to ensure alignment with the City's commitments to diversity, equity, and inclusion.

We welcome the opportunity to collaborate with the Park Board in the development of inclusive, respectful, and representative public programming that affirms the dignity and safety of all Vancouver residents.
