1. Civic Updates

Eric Fredericksen, Head of the Public Art Program, provided brief updates on *Platforms: We Are Here, Live*; noting that Vancouver has commissioned 23 emerging and established Vancouverbased artists to create pieces that reflect the complexities of the COVID-19 pandemic, to be presented on platforms across Vancouver. The next Platforms program, for 2023, will focus on Musqueam, Squamish, Tsleil-Waututh artists, and other Indigenous artists living in Vancouver.

2. Strand – 360 W 2nd (DPAP)

At 5:19 pm, prior to the start of Item 2, Marc MacCaull declared a Conflict of Interest, as Strand is his current employer; Marc exited the meeting and returned at 6:04 pm, following the completion of the presentation and preliminary discussion on Item 2.

Emmy Lee Wall, Public Art Consultant, provided an introduction and Taizo Yamamoto, Architect, and Alison Meredith, Public Art Consultant, presented the detailed public art plan (DPAP) for a new development in the Mount Pleasant Industrial Area, highlighting the neighbourhood context per request from the Committee when the preliminary public art plan (PPAP) was first introduced to the Committee on September 19, 2022.

3. GEC Oakridge 441-475 W 41st (DPAP)

Jan Ballard, Public Art Consultant, along with Donald Yen, Architect, and Katja Lichenberger, Public Art Consultant, presented the detailed public art plan (DPAP) for a new development in the Cambie Corridor and Oakridge neighbourhood. The preliminary public art plan (PPAP) was first introduced to the Committee on September 19, 2022.

4. PCI - 1477 W Broadway (PPAP)

Jan Ballard and Jenn Jackson, Public Art Consultants, along with Peter Odegaard, Architect, presented public art opportunities for a new development that will be integrated with the future South Granville station on the Broadway Subway extension.
