- That barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated;
- In consideration to significant increase in fees for the artists, the community, the advisory group, and the selection panel (due consideration to CARFAC);
- To clarify the process between the artists, the community advisory group, and the selection panel:
- The selection panel members be able to make suggestions for the long list;
- That both the selection panel and the community advisory group have at least one artist on each;

- That the public art plan includes some biographical information on posed panel member and advisory groups;
- Consider the possibility of media works involving electricity and lights and multimedia;
- Consider visibility to users of the BC parkway path and possible tie-ins between the BC public parkway and the art.

- That barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated:
- Consider including precedents for artwork using utility infrastructure that would be applicable for the site, with an eye to dynamism;
- Strongly encourages the selection process to focus on selection and inclusion of Queer and BIPOC artists.
