Jan Ballard, Public Art Consultant, presented the Detailed Public Art Plan (DPAP) for this new development in the West End neighbourhood, and responded to questions and comments.

4. Reviews and Motions

WHEREAS

- On March 10, 2025, the Public Art Committee received the Public Art Master Plan for multiple Amica Seniors Community Care Facilities (Amica – Intracorp – Marcon), and further considered the proposal on April 14, 2025;
- The Public Art Committee operates within a system that is embedded in colonial structures that have and continue to exclude and are harmful to Indigenous and marginalized communities;
- 3. There are no representatives of Musqueam, Squamish, or Tsleil-Waututh (MST) on the Public Art Committee;

THEREFORE BE IT RESOLVED

- A. THAT the Public Art Committee recommend approval of the Public Art Master Plan for multiple Amica Seniors Community Care Facilities Facilities (Amica – Intracorp – Marcon), as presented on March 10, 2025;
- B. THAT the Public Art Committee note concerns with the Public Art Consultant's approach, specifically insufficient
 - o literacy on First Peoples (e.g., the proposal exhibits a lack of understanding of nations/Indian bands, MST languages, etc.);

- progress on equity in processes of selection of artists and long-lists (no identification of barriers and no strategies for mitigating those barriers have been made explicit);
- o ongoing and relational engagement with MST communities;

C. THAT the Public Art Committee recommend the Public Art Consultant

- continue working with the anti-oppression specialist in the identification of barriers for equity-seeking groups in the selection of long-lists, panels, and advisors and strategies for addressing those barriers be implemented and demonstrated;
- pursue training to develop literacy on MST peoples;
- commits to pulling artists from a pool of exclusively Musqueam and Tsleil-Waututh artists, with an emphasis on disability, for the next 4 artist selections or 1.4 million dollars of public project funds, whichever is longer to correct for the 4 opportunities for other artists lost due to this proposal;
- in collaboration with the artist, develop and make explicit a framework for relational engagement (e.g., apprenticeship, mentorship, Nation-to-Nation dialogue) that is culturally sensitive, and allocates budget accordingly;
- o follow the lead of the artist in regards to relational aspects of the project;

FURTHER THAT it be noted these recommendations are directed to the Public Art Consultant, not the artist, with the intention of enhancing equitable engagement and community representation.
