• Intracorp - 3362 – 3384 Vanness Ave (DPAP)

- Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated;
- Artist honorarium be increased to \$7-8K range;
- An open call be issued .

- The applicant continue to identify barriers for equity-seeking groups in the selection of long-lists, panels, and advisors, and strategies for addressing those barriers be implemented and demonstrated;
- Encourage and support artists to explore the potential of dynamic works at the intake;
- Encourage the public art consultant to distribute the artist submission link on their website.

## • Sightline - 1726 W 11th Ave (PPAP)

FURTHER THAT the Public Art Committee recommend the following in developing the detailed public art plan:

- The public art consultant be more imaginative, thoughtful and integrative on the placement and incorporation of public art throughout the development including areas that might be defined by the artist and responsive to the community;
- Clarification that the selection process is an open two stage process, not a direct commission and to allocate artist honorarium in the budget so that artists are compensated for their time;
- Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated.
