1. Mondivan – 2110 W 5th Avenue (PPAP)

3. Review and Motions

THAT the Public Art Committee receive for information the preliminary public art plan (PPAP) for the development located at 2110 W 5th Avenue, as presented;

FURTHER THAT the Public Art Committee recommend the following in developing the detailed public art plan:

- Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated;
- The public art consultant be more imaginative, thoughtful and integrative on the placement and incorporation of public art on the development including areas that might be defined by the artist and responsive to the community and inclusion of accessible public signage;
- Include brief biographies of those proposed for the community advisory and artist selection panel to explain what they bring to the process;
- Ensure artist involvement in the panels, not just art professionals;
- Artist proposal fee should be at least doubled considering CARFAC guidelines;
- Provide more detailed information about what the public artwork includes and what is the responsibility of the artist, and what supports the developer and public art consultant will provide the artist during installation.

THAT the Public Art Committee receive for information the preliminary public art plan (PPAP) for the development located at 701 Kingsway, as presented;

FURTHER THAT the Public Art Committee recommend the following in developing the detailed public art plan:

- Research possibilities for artworks with potential links with McAuley Park;
- Consider any sound issues in consideration of the public art, including echoes from street noise, sound absorption of material including plants, and the water feature as well as the possibility of sound-based work;
- Continue to identify barriers for equity-seeking groups in the selection of long-lists, panels, and advisors, and strategies for addressing those barriers be implemented and demonstrated;
- Better integrate the equity statement policies with proposal requirements and selection processes;
- Consider the seniors community in the neighbourhood for community engagement and the advisory panel;
- Reconsider the developer's contingency to establish a higher allowance for unforeseen additional costs.
