THAT the Public Art Committee receive for information the Preliminary Public Art Plan (PPAP) for the development located at 461–475 E 16th Ave as presented;

FURTHER THAT the Public Art Committee recommend the following in developing the Detailed Public Art Plan:

- 1. Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated:
- 2. Do not differentiate between site 1 and site 2 as potential sites for public art, and instead consider it as one integrated site;
- 3. Add wording that reflects the following motion passed by the Public Art Committee on October 20, 2026:

THAT the expectation of Public Art Committee is that the future public art plans demonstrate a high degree of imagination, thoughtfulness and integration on the placement and incorporation of public art opportunities in the development, including areas that might be defined by the artist and responsive to the community;

- 4. Community advisory panel and selection panels be provided the opportunity to make recommendations before the long list of potential artists is established;
- 5. Include an explicit outline of methods of collaboration between architects and artists in the early stages of the process before architectural design is finalized;
- 6. Consider increasing the artist fee beyond the bare minimum recommended by CARFAC.

- Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and demonstrated;
- 2. Have more openness in media, structure, and concept beyond the pavilion, for example a public media screen and potential collaboration with VIVO;
- 3. Provide guarantee of public access to the privately owned public space (POPS) identified as the public art site location through the agreement process.

FURTHER THAT the Public Art Committee recommend the following in developing the Detailed Public Art Plan:

1. Barriers for equity-seeking groups in the selection of long-lists, panels, and advisors be identified and strategies for addressing those barriers be implemented and

demonstrated;

- 2. Include an explicit outline of methods of collaboration between architects and artists in the early stages of the process before architectural design is finalized;
- 3. Special attention be given to the current artists operating on site for opportunities to provide public art, as well as for positions on the community advisory and selection panels;
- 4. Explore the opportunity with public art staff to withhold an allowance of funds for future mural opportunities along Main Alley in lieu of providing completed murals at occupancy;
- 5. Include Local First Nations in the selection panel;
- 6. Include outcomes of early stakeholder and community engagement.
