6. Liaison Updates

Councillor Swanson, Council Liaison, provided information on the following:

- draft potential amendments for the Report dated April 27, 2022, entitled "Broadway Plan", being presented to Council at the Standing Committee meeting on Policy and Strategic Priorities meeting on May 18, 2022, and reconvening on May 25, 26 and 31, 2022, and asked the Committee for their input;
- Council Member's Motion entitled "<u>Asking for a Change to the Vancouver Charter to Allow the City to Levy a Progressive Property Tax</u>", that was dealt with at the Standing Committee on Policy and Strategic Priorities meeting on April 13, 2022; and
- Council Member's Motion entitled "Emergency Actions to Protect SRO Tenants from Displacement to Save Lives", that will be on the agenda at the Council meeting on June 7, 2022, and asked the Committee for their input.

- current discussions happening at UBCM in regards to the rental housing crisis;
- the Referral Report dated March 28, 2022, entitled "CD-1 Rezoning: 4949-5255 Heather Street and 657-707 West 37th Avenue (Heather Lands)", that was discussed and approved by Council at the Public Hearing on May 24, 2022; and
- potential amendments being considered for the Report dated April 27, 2022, entitled "Broadway Plan", being presented to Council at the Standing Committee meeting on Policy and Strategic Priorities meeting on May 18, 2022, and reconvening on May 25, 26 and 31, 2022.

4. A Motion to Advise Council to Amend, Improve, and Pass the Broadway Plan Proposal

MOVED by Jacint Simon SECONDED by Travis Barker

WHEREAS

- 1. The City of Vancouver has a deficit of 86,000 units of housing;
- The City of Vancouver is required to pass a Local Area Plan in order to meet its obligations under its Support Agreement with TransLink for The Broadway Subway Line; and
- 3. The Renters Advisory Committee finds the supports and protections for renters in the Broadway Plan sufficient.

THEREFORE BE IT RESOLVED THAT the Renters Advisory Committee endorse the Broadway Plan as currently presented to Council;

FURTHER THAT the Renters Advisory Committee encourage Mayor and Council to adopt expanded renter protections and vacancy controls in order to encourage 20% rental affordability over-and-above those provided Right of First Refusal under the Broadway Plan;

AND FURTHER THAT the Renters Advisory Committee encourage Mayor and Council to add much needed density away from the Broadway Corridor in order to mitigate impacts of displacement to current renters, including non-market housing solutions like co-ops, Council Housing, and supported housing.
