- 2. Appoint an Indigenous Elder as an honorary member of the Commission to provide input to the Commission through an Indigenous lens.

Commissioner Seymoar noted that Advisory Bodies will now have joint quarterly meeting four times per year, and as such doesn't feel the need to pursue her first proposed motion. The Commission then discussed the idea of having an Indigenous Elder as an honorary member of the Commission.

• Commissioner Perl suggesting seeking an Indigenous advisor or facilitator for the working session in April.

Commissioner Perl, Nominations Committee, provided an update to the Committee's principles for the Executive Committee nominations as well as a brief summary of the roles available on the Executive Committee.

THAT the Vancouver City Planning Commission increase the Executive Committee membership from three to four members and maintain an open call for expressions of interest in electing Executive Members.
