a) PRESENTATION: Downtown Waterfront Working Group (External)

Christina DeMarco and Tom Phipps, Downtown Waterfront Working Group, provided a presentation on, "The Future of the Downtown Waterfront". The presentation included an overview of the Downtown Waterfront Working Group, Vancouver City Planning Commission's involvement and interest, the office tower proposal, planning context, including past and present, and the advocacy's timeline, and areas of focus.

c) VCPC Commissioner Appointment Discussion

THAT the Vancouver City Planning Commission appoint Marnie Tamaki as a Commission appointee, effective immediately and until December 31, 2022.

3. LIAISON MEMBER REPORTS

a) Reports form Liaison Members

Trustee Janet Fraser, Vancouver School Board (VSB) Liaison, provided an update on the December 14, 2020, School Board meeting:

- The VSB 2021/22 budget timeline was finalized, with approval by the end of April;
- Policy 21, Anti-Racism and Non-Discrimination, was updated following review by an independent expert; and
- A request will be made to the Ministry of Education to reinstate the position of Chief Educator.

In addition:

- The amended 2020/21 budget will be considered in February. There is concern about loss in revenue from International students and rentals, as well as whether additional costs were incurred Sept-Dec 2020; and
- The draft 2020 Long Range Facilities Plan is being considered at committee and is targeted for approval this month.

Commissioner Irwin, Park Board Liaison, provided brief updates on the following:

- The 2021 Service Plan, Operating & Capital Budgets approved;
- Community Centre classes switched to virtual classes;
- Strathcona Park encampment transitioning to Jericho Hostel;
- Climate Emergency Response, Green Operations, and Climate Change Adaptation staff report scheduled for future board meeting;
- Shape Your City survey results, 70% want more room for cyclists, will be moving ahead in spring or fall 2021; and
- Indigenous Food Trucks re-launching.

Councillor Fry, Council Liaison, provided brief updates on the following Council activities:

- Council approved 2021 Operating and Capital Budgets;
- Strathcona Park Encampment still has significant issues that may continue over the long term if the Province does not step in with funding;
- COVID-19 pandemic is straining local businesses, but surprised interest in new office spaces;
- Oakridge Transit Centre, with mix of affordable and market rentals on site approved by Council;
- Vancouver Bird Strategy approved;
- New subcommittees and regional bodies approved; and
- Single-use Item Reduction Strategy pulled back due to COVID-19, and will proceed as a bylaw, with no enforcements and fines until 2022.

Lisa King, Planning and Development Services, provided brief updates on the following:

- Vancouver Plan update includes November kick-off survey with engagement results from public on Council provisions in the fall;
- Vancouver Plan SFU talks being developed;
- The Future We Want: Conversation Kit | The Vancouver Plan are available online and at Vancouver Public Library branches; and
- Employment Lands and Economy Review Quick Start Actions, scheduled for Public Hearing, January 21, 2021.

4. COMMISSIONER REPORTS AND DISCUSSION

a) Report on Urban Design Panel
