WHEREAS 507 Hawks Avenue, 515 Hawks Avenue (VHR "B" listing), and 521 Hawks Avenue (VHR "B" listing) were erected between 1903 and 1904, and are valued for being the earliest known examples of the British Columbia Mills Timber and Trading Company (BCMTT) prefabrication system; are three of only eight known BCMTT buildings remaining within Vancouver; are the only surviving grouping of BCMTT houses in the city; and as working-class rental homes for most of their existence;

THEREFORE, BE IT RESOLVED THAT the Vancouver Heritage Commission supports:

- 1. The overall proposal to subdivide the existing land parcel into three lots, one lot for each house:
- 2. The heritage designation of 515 Hawks Avenue and 521 Hawks Avenue; and
- 3. The rehabilitation of and Conservation Plan for 515 and 521 Hawks Avenue as presented at the June 20, 2022 VHC meeting.

# 2. 102 East Pender Street (Sun Ah Hotel and Ho Ho Restaurant) VHR 'B' SI-2021-00527 / SI-2021-00528

WHEREAS 102 East Pender Street (the Sun Ah Hotel and Ho Ho Restaurant) was built in 1912 and is listed in the "B" category on the VHR and municipally designated, and is valued for epitomizing the hand-built values of the Arts and Crafts style guiding the work of its architect Richard T. Perry; for its association with businessman and developer Loo Gee Wing and the Sun Ah Hotel reflecting the pattern of immigration and development in Chinatown; and for its long association with both the Lung Kong Tien Yee Association, and the Ho Ho Restaurant which was opened in 1954 by the Quon family, and whose neon signs were once an iconic and important landmark in Chinatown;

THEREFORE BE IT RESOLVED THAT the Vancouver Heritage Commission supports:

- 1. The replications of the Ho Ho Signage;
- 2. The Conservation Plan (as presented at the June 20, 2022 VHC meeting) for the Pender Street façade of the Sun Ah Hotel/Ho Ho Restaurant, and the installation of new neon signs based on the 1950's original signs; and
- 3. A façade grant of up to \$50,000, per the Heritage Façade Rehabilitation Program Policies and Procedures; and

FURTHER THAT the Vancouver Heritage Commission requests that the new Ho Ho Restaurant signage will be authentic neon signs made of neon tubing, not LED "neon-like" tubing.
