1. Unfinished Business

Vancouver Heritage Commission completed Item 2: VHC SoS Subcommittee from the September 9, 2024, meeting.

THAT the Vancouver Heritage Commission support adding 215 West 1st Avenue, 144 East 6th Avenue, and 148 East 6th Avenue to the Vancouver Heritage Register as B, A, and C-listings, respectively;

FURTHER THAT the VHR evaluations be referred back to Staff to complete the necessary revisions.

2. Western Canada Building, 416 West Pender Street (VHR) Façade-only Retention with Heritage Designation

WHEREAS

- 1. The Western Canada Building at 414-420 West Pender Street is listed on the Vancouver Heritage Register and located in the Victory Square area which has a significant number of buildings of heritage significance;
- 2. Fastmark is proposing to rezone 414-420 West Pender Street from DD to CD-1 to allow for the development of a 12-storey residential rental building and the preservation and restoration of a 1914 two storey façade at the base of the building;

THEREFORE BE IT RESOLVED

A. THAT the Vancouver Heritage Commission support the proposed preservation and restoration of the two storey 1914 façade, including the front entrance and floor tiles, if possible, and the proposed upper-level setbacks including the setback of the third storey above the 1914 façade, and setback of the higher levels of the building addition to ensure the corner cornice return of the building to the east is visible.

- B. THAT the Vancouver Heritage Commission encourage the applicant to explore opportunities for salvaging and repurposing interior elements including the existing balustrade, heavy timber, and other materials.
- C. THAT the Vancouver Heritage Commission support the designation of the 1914 heritage facade of the building at 414-420 on the Heritage Register.

3. The Grange, 1395 West 14th Avenue (VHR) Partial Building Retention with Heritage Designation

WHEREAS

- 1. The Grange Apartment Building at 1375-1395 West 14th Avenue is listed on the Vancouver Heritage Register and the Broadway Plan identifies that the South Granville area as having a significant number of buildings of heritage significance worthy of retention;
- 2. Colliers is proposing to rezone 1375-1395 West 14th Avenue from RM-3 to CD-1 to allow for the development of a 20-storey residential rental building and the preservation and rehabilitation of portions of the 1932 three storey façade of the apartment building;

THEREFORE BE IT RESOLVED

A. THAT the Vancouver Heritage Commission support the proposed preservation and rehabilitation of the three storey 1932 façade, including the front entrance and floor tiles, and the proposed upper-level setbacks including the setback of the tower from the 1931 façade;

- B. THAT the Vancouver Heritage Commission supports the designation of the 1932 heritage facade of portions of the building at 1375-1395 West 14th Avenue on the Heritage Register;
- C. THAT the Vancouver Heritage Commission encourage the applicant to incorporate indigenous landscaping and design elements into the site, the tower design, and public art.
