# **ADOPTION OF MINUTES – January 6, 2025**

1. Marine Building, 355 Burrard Street (VHR, M)
Heritage Incentive Program Grant Application
DB-2024-03407

Staff received an application (DB-2024-03407) from Oxford Properties Group that includes seismic upgrading and conservation work on the Marine Building, addressed 355 Burrard Street. The heritage building is characterized as a multi-storey, steel-frame structure with masonry cladding (primarily brick, terra cotta, and granite). Completed in 1930, it is considered a landmark structure that is a premier example of Art Deco architecture in western Canada. The major proposed scope of work outlined in the Conservation Plan include:

• pinning and anchorage of exterior masonry elements (brick, terra cotta and granite)

- replacement and/or addition of shelf angles (including
- replacement and/or repair of masonry units (fracture/patch repairs)
- masonry repointing and cleaning
- abatement of hazardous materials

The proposed scope of work is generally consistent with Vancouver Heritage Program, Heritage Policies, and *Standards and Guidelines for the Conservation of Historic Places in Canada*. The application demonstrates a high level of retention and conservation, with verifiable seismic upgrading, and is eligible to receive a grant under the Heritage Incentive Program (HIP). Based on staff review that is underway, the preliminary grant recommendation is within the magnitude of \$3.5 to 4 million.

Staff are seeking comments on the Heritage Conservation Plan, in particular the scope of work that are eligible for financial incentive under the Heritage Incentive Program.
