

Further to the May 14, 2019, and August 2, 2019 memos on Blood Alley Square (attached), this memo provides an update to Mayor and Council on the Blood Alley Square tree management plan.

As per the Blood Alley Square tree management plan, on April 2, 2020 three unhealthy trees and one tree stump (previously damaged during a weather event) were removed in coordination with the adjacent development construction activities, and of the trees being retained, two trees were pruned.

Blood Alley Square is an important public space, and the redesign aims to create a space that is inclusive and respectful of its heritage assets and intended tree canopy, surrounding urban area, and social and community context guided by the nine social impact objectives in the Downtown Eastside (DTES) Plan.

The tree management plan was based on feedback received during public consultation on the Blood Alley Square redesign and it includes the retention of five trees within the Square. Additionally, we have developed a tree succession strategy that incorporates the planting of two large size specimen trees. This will ensure that the tree canopy is restored and enhanced when the redesigned Square is implemented. The City will also be exploring locations near Blood Alley Square to plant additional street trees to ensure there is no net loss of trees related to the project.





Blood Alley Square Public Engagement Summary and Next Steps

Further to the May 14, 2019 memo on Blood Alley Square, this memo provides information to Mayor and Council on engagement feedback, resulting changes to the tree management plan and next steps.

Blood Alley square is an important public asset, and the redesign aims to create a space that is inclusive and respectful of its heritage assets, surrounding urban area, and social and community context guided by the nine social impact objectives in the Downtown Eastside (DTES) Plan.

An open house for the project was held on May 15, 2019, to seek feedback on the design for Blood Alley Square in Gastown which was informed by public and stakeholder feedback from previous open houses, questionnaires and meetings.

The May 15 open house was attended by a total of 231 people. 93 respondents provided feedback on the Blood Alley Square redesign by completing a questionnaire accessible between May 16 and June 16, 2019. The results of the hard copy and online questionnaire, and feedback from conversations at the open house indicate that there is overall support for the design presented; feedback emphasized a strong desire to retain as many existing trees in the square as possible.




The tree management plan for Blood Alley Square initially retained four of nine existing trees that were evaluated by a professional arborist and determined healthy enough to have the highest likelihood of survival. The trees that are scheduled to be removed are noted to be unhealthy and not likely to survive. In direct response to feedback received during public consultation, the tree management plan has been updated to retain an existing significant tree located at the northern edge of the square for a total of five retained trees. Additionally, we have developed a tree succession strategy that incorporates the planting of two large size specimen trees that will replace existing trees that are to be removed due to their poor health. This will ensure that the tree canopy is restored and enhanced. The City will also be exploring locations near Blood Alley Square to plant additional street trees to ensure there is no net loss of trees related to the project.

Next steps will include distribution of a consultation summary in August 2019, commencement of unhealthy tree removals in summer of 2019 in coordination with the adjacent development, design refinement based on feedback received at the May 15 open house, engagement with local stakeholders to develop community partnerships for stewardship of Blood Alley Square, and coordination of a final design open house in conjunction with the Gastown Complete Streets Project in early 2020.
