City to expand Drinking in Plazas Program beyond summer months

Following three successful seasons, Vancouver City Council has voted to expand Vancouver÷s<u>Drinking in Public Plazas Program</u> into a year-round initiative. As part of its decision, Council has approved six public plazas to participate in the new 2023/24 program.

"Time and time again we have seen that Vancouverites can be trusted to safely and responsibly enjoy alcoholic drinks in shared public spaces. We're incredibly pleased to support the expansion of this program," says Mayor Ken Sim. "Community connection and spaces for public life are so important for our wellbeing and quality of life. Having plazas that allow alcohol consumption year-round will help make our city more vibrant while supporting local businesses."
