1. Week at a Glance

1.A Key Government Announcements Impacting the Business Community (<u>Appendix A</u> for links):

New key announcements by all levels of government include:

- Federal Government:
 - Canada Emergency Wage Subsidy ("CEWS"): Businesses will be able to apply beginning April 24th, with a goal of having 90% of claims processed by May 4th and payments landing later that week
 - Canada Emergency Commercial Rent Assistance ("CECRA"): A agreement has been formed with provinces to subsidize commercial rent by up to 75% for small businesses with monthly rent below \$50,000 in April, May, and June.
 - Canada Emergency Student Benefit ("CESB"): Comprehensive support of nearly \$9 billion for post-secondary students and recent graduates, including an additional 76,000 summer jobs
 - Canada Emergency Response Benefit ("CERB"): As of April 23, 2020, 9.51 million application had been processed
 - National Research Strategy: \$1.1 billion national research strategy for the fight of COVID-19, including: \$115 million for vaccines and treatment, \$662 million for investment in clinical trials, \$350 million to expand national testing
 - Indigenous Post-Secondary Students: \$75 million for Indigenous post-secondary students
 - Indigenous Business: \$306.8 million in funding for Indigenous SMEs
 - Community Groups and National Charities: \$350 million for community groups and national charities that help seniors, homeless and other vulnerable communities
 - Ministerial Coordination Group on COVID-19: Declaration of international collaboration to manage the impact of COVID-19
 - COVID-19 Immunity Taskforce: Investigating immunity to COVID-19, and the percentage of the population with immunity
 - Sharing of Resources: Canadian Centre for Occupational Health and Safety has created a platform for businesses to share pandemic-related resources
 - Border Restrictions: Canadian/US border restrictions have been extended another 30 days

- Provincial:
 - Provincial Action Plan: \$36.5 million of the \$5 billion provincial action plan will be used to continue services at group homes for 9,500 adults with development disabilities
 - Price Gouging: Law enforcement officers may now issue \$2,000 tickets for price gouging and reselling of medical supplied during pandemic
 - Rural, Remote and Indigenous Communities: A new collaborative framework to ensure the health care system is better meeting the needs of these communities
 - BC Emergency Benefit for Workers: \$1,000 one-time, tax-free payment from the Province for people who have lost their job due to COVID-19; applications open May 1st
 - Computer Learning: The Province has loaned over 23,000 computers and devices to students to allow them to continue their education from home
- City of Vancouver:
 - Launched a <u>COVID-19 Dashboard</u> that allows the public to track the City's emergency response and efforts
 - A partnership between the City of Vancouver and Mobi by Shaw will provide a free 90day pass to essential service workers
 - Resumed enforcement of parking in Kitsilano and Point Grey neighbourhoods

1.B Economy at a Glance

There are still significant variations in GDP forecasting owing to uncertainties about how long public health measures – such as social distancing and business closures – will continue:

- Economic GDP forecasts for BC in 2020 range from drops of –11.4% (BC Business Council, if closures continue throughout the year) to +0.6% (Central 1 Credit Union, with earlier easing or lifting of restrictions)
- Most forecasts show BC to be in a better position than Canada overall, with an ability to bounce back faster after restrictions are lifted

1.B.b British Columbian Economy at a Glance

- Province of BC continues to maintain a long-term debt rating of AA and a short-term debt rating of R-1 (high), as of April 21, 2020 – <u>Morningstar, British Columbia, Province of: Rating Report</u>
- The BC Supreme Court has rejected request for an interim injunction for the Speculation Tax: court case Bacon et al v. The Queen 2020 BCSC 578 – <u>BC Supreme Court judge reject</u> <u>injunction sought by homeowners against speculation tax</u>
- ICBC has been granted approval by the BC Utilities Commission to implement temporary changes due to COVID-19. Measures include waiving cancellation charges (non-fleet owners); allowing suspension of basic insurance and refunds without the need to cancel plans (fleet owners); and allowing certain rate classes to temporarily use vehicles for delivering food and medical products without additional premiums <u>ICBC, April 23 Update on COVID-19</u>
- The Province has invested \$38 million through the Province's childcare matching process, allowing over 2,650 essential service workers, with children up to 5 years have age, have access to reliable childcare – <u>British Columbia Government News, B.C.'s essential service workers</u> <u>matched with child care</u>
- Based on infection rates and the extend of business closures, BC looks to be in a better position than several other Provinces and American States, however, the world-wide recession and mandated business closures are pummeling the BC economy. – *Business Council of BC, Ken Peacock, Chief Economist and Vice President*
- The sectors hardest hit in BC include: Air transportation; Accommodation (hotels, motels, etc.); Hospitality; Entertainment, leisure and recreation services; Film and television production;

Advertising, public relations and related services; Manufacturing; Real estate services; Legal and accounting services; Retail trade (other than hospitality) – *Business Council of BC, Ken Peacock, Chief Economist and Vice President*



1.C Local Industry-led innovations and mitigations

Businesses and industry associations are moving quickly to support the survival of the businesses, innovate, and turn to recovery. Some local examples include:

- New Apparel Business Model: <u>Duer</u>, a Gastown-based apparel company, is now crowdsourcing customer interest in a new design before heading to production to better meet demands and interest, reducing the cost to consumer by 20–30%.
- Motion Picture Sector Return-To-Work: VEC and Creative BC have convened a working group to start economic modelling scenarios to start up the motion picture sector again.
- Safety Innovations for In-Restaurant Dining: Dr. Bonnie Henry is <u>challenging</u> the restaurant industry for innovative ideas on how they can allow for in-restaurant dining as restrictions are

slowly eased. In response the BC Restaurant & Food Services Association has formed a <u>taskforce</u> to meet this challenge and plan to present to the Province in two weeks.

- Telus Mobility for Good COVID-19 Emergency Response Program: <u>Donating</u> more than 10,000 mobile devices with \$0 rate plans to enable vital connections for those who need them most.
- Precision Nanosystems: A Vancouver-based biotech company supporting biopharma companies through its development platform has <u>15 users</u> developing COVID-19 vaccines worldwide.
- Clean50 Calls for Clean Reset: 210 leaders in the Canadian green economy composed a <u>letter</u> to the government calling for a clean reset for a healthy, just and prosperous Canada.

1.D Key Findings from COVID-19 Impact Pulse Check Survey #2

Led by BC Chamber of Commerce, Greater Vancouver Board of Trade, Business Council of British Columbia, and the Mustel Group with survey results published every two weeks.

2. Industry's Priority Asks for Government

Industry feedback has been collected through key VEC stakeholder channels and partners with respect to current Government stimulus packages and outstanding needs of the business community.

Top outstanding asks to Government

Federal Government

- Clarification for the interaction of CERB, CEBA and CECRA, and how/if businesses may access multiple funding options
- Making CEWS program accessible to public sector entities and agencies to benefit organizations such as TransLink
- GST/HST relief waiver for the first quarter of 2020 to relieve financial stress for businesses
- \$10 billion loan to increase liquidity across all areas of tourism, including hospitality and restaurants
- Automatic extensions to temp. foreign workers who lost their jobs from the pandemic to find new employment within the same sector; relax TFW requirements to work exclusively for one company
- Clarification of whether film and entertainment workers qualify for EI and CERB assistance
- Waive deferred taxation to remove barriers to reopening
- Provide training and subsidies for businesses to create online revenues
- Negotiate attractive business prices for telecommunications across the country and support for online transactions and remote work

Provincial Government of BC

- To use Provincial power to requisition hotels for people without homes, decreasing the dependency on tent cities where the risk is higher for COVID-19 transmission
- Development of safe reopening strategies for businesses in advance of restrictions being lifted to enable businesses to plan for budgets and staffing

- Temporarily suspend hotel tax before lifting restrictions, and continue to work with the Federal government to fund tourism associations to support regrowth in the sector
- Provincial health authorities must develop clear guiding principles early in order for businesses in these sectors to plan for reopen and ramp up
- Invest in return to service by public transportation
- Waive deferred taxation to remove barriers to reopening
- Invest in entertainment industry to ensure there are events for tourists to attend
- Provide training and subsidies for businesses to create online revenues
- Incentivize local food purchasing in food services and accommodation across the province (over and above non-Canadian sources)

City of Vancouver

- Creation of a commercial tenants' board to advocate for a moratorium on evictions and be a source of information for both tenants and landlords
- For current and forecasted demand of PPE, as manufacturers are considering ramping up supply or retooling their facilities
- Expand standard hours of construction, that social distancing protocols may be followed to a higher degree at job sites
- Plan streetscape to accommodate increased delivery service for the longer term
- Reduce costs at civic theatres and encourage packages for increased provincial tourism
- Waive deferred taxation to remove barriers to reopening
- Establish fast-track permit office for businesses retuning under new health and safety guidelines which may require renovations and floor plan adjustments plus patio extensions
- Resolve zoning, taxation, and building permits for urban agriculture that can supply the food service and accommodation sectors with fewer transportation, seasonality, and climate risks
- With partners, establish a local food hub in False Creek Flats for greater access to local produce and food products (similar to South Van Food Hub)
- Launch a campaign for 'Open for Business' encouraging locals to dine out and shop local, British Columbians to visit and attend theatre, etc., and conferences to return to Vancouver

- Canada Emergency Commercial Rent Assistance ("CECRA") to subsidize commercial rent for small businesses
