### PURPOSE

The purpose of this memo is to update the recommended locations listed in Appendix A in the Report "2021 Alcohol Consumption in Public Plazas Pilot" (RTS 14335).

### BACKGROUND

This report recommends to Council:

*THAT Council approve, in principle, amendments to the City Land Regulation By-law No. 8735 to designate certain public places over which the City has jurisdiction as places where liquor may be consumed;*

*FURTHER THAT the Director of Legal Services be instructed to bring forward for enactment by Council a By-law to amend the City Land Regulation By-Law to designate these places, generally as set out in Appendix A.*

Appendix A includes a location at Maple Street and West 4<sup>th</sup> Ave (Designated area 5). Today staff received additional feedback from emergency services specific to the Maple St and W 4th Avenue pop up plaza location that will require additional review. As a result, staff are not recommending including this location in the pilot at this time. We may bring the location forward for council consideration once we have had the opportunity to review and address this new information. This does not impact the other proposed locations for Council's consideration.

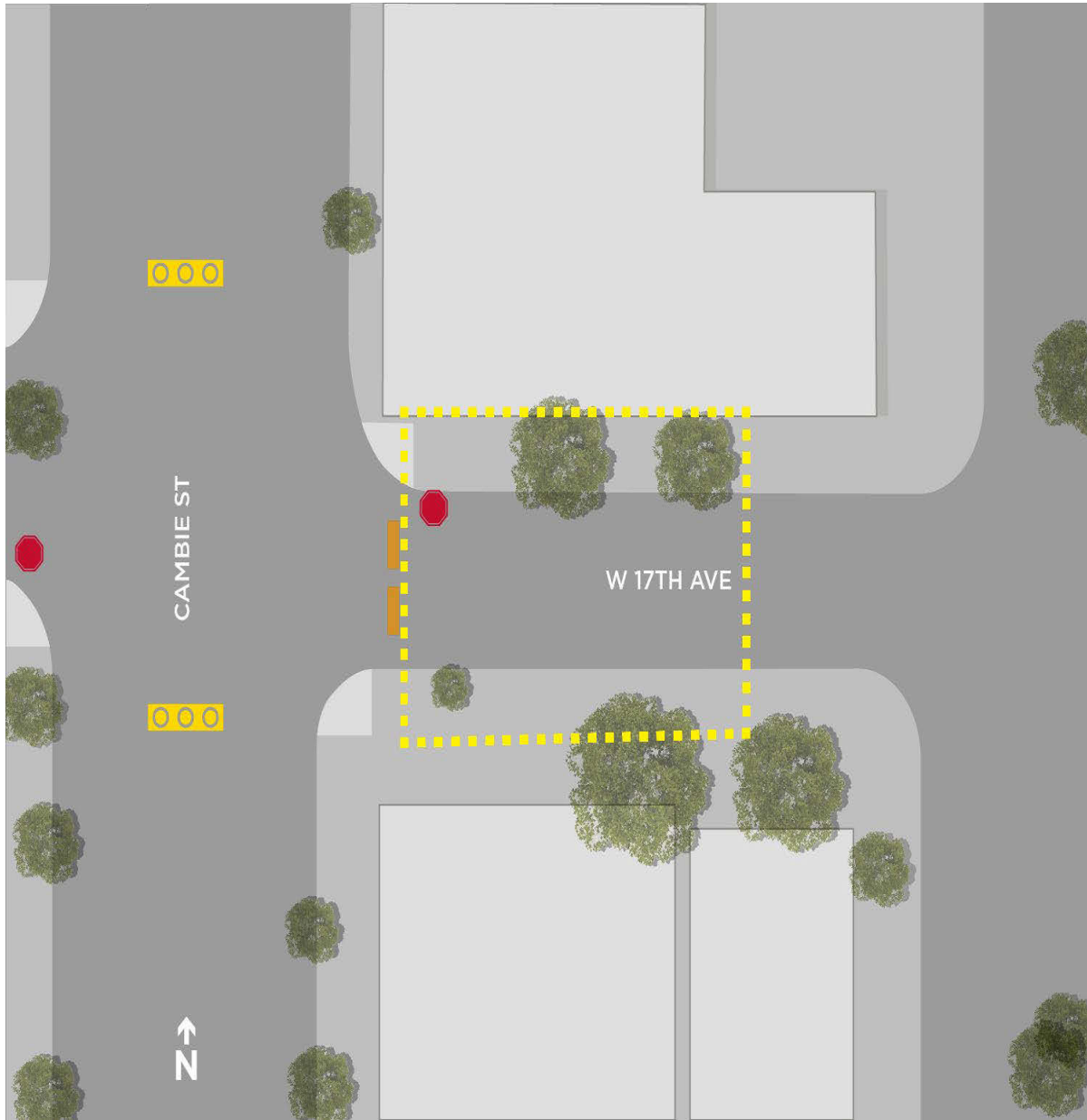

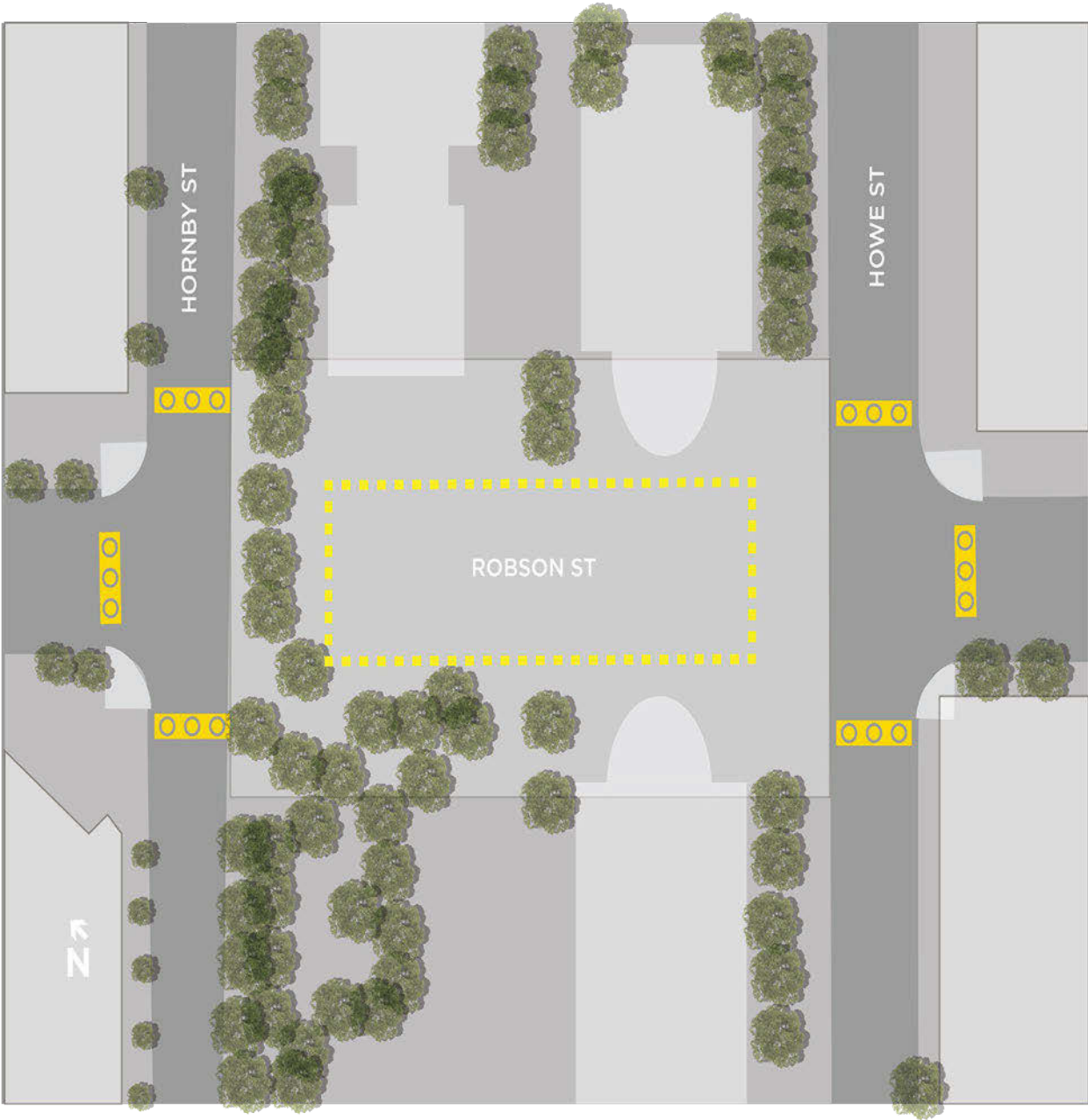

City Land Where Liquor May be Consumed

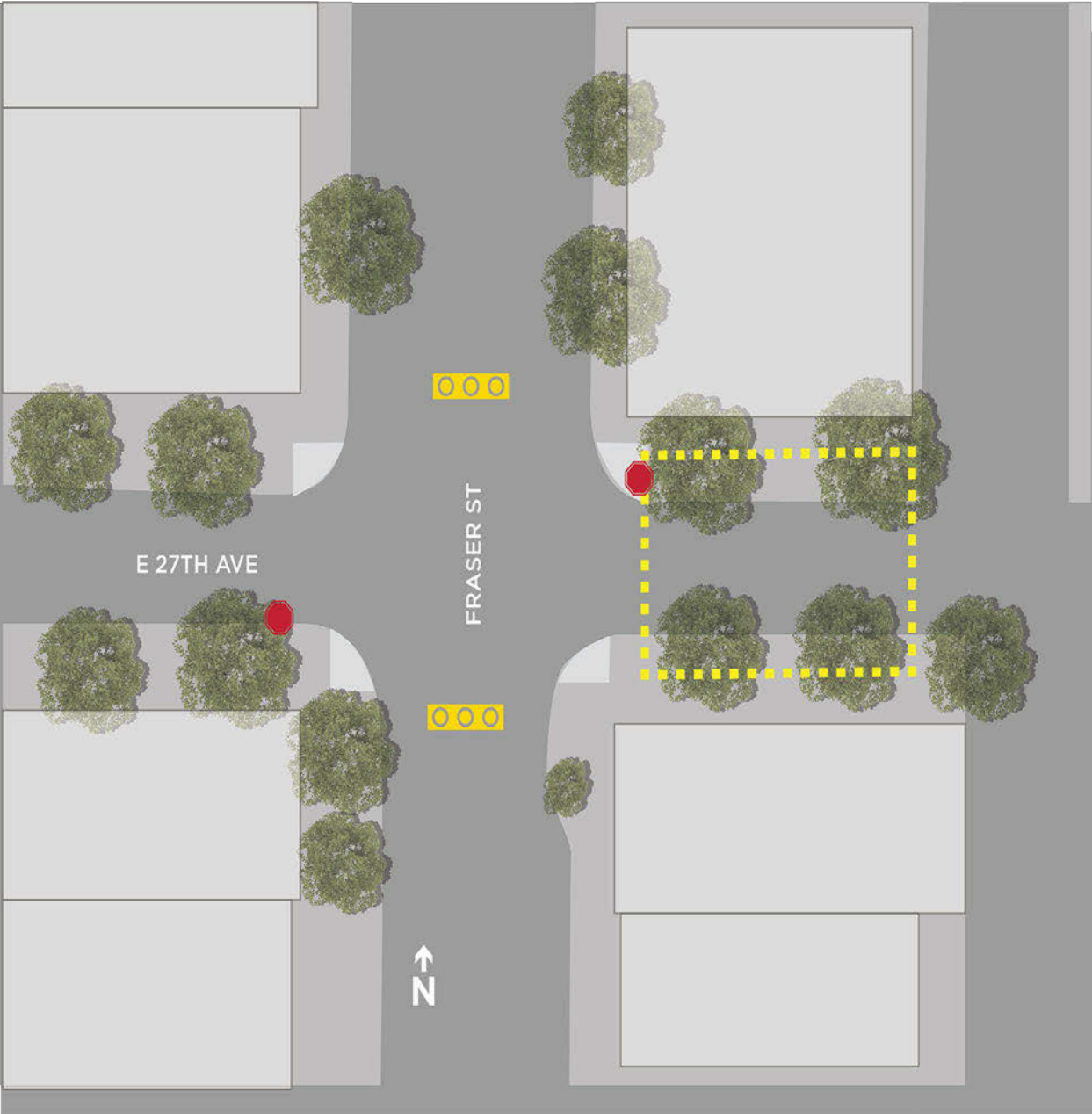
Designated area 1



Designated area 2

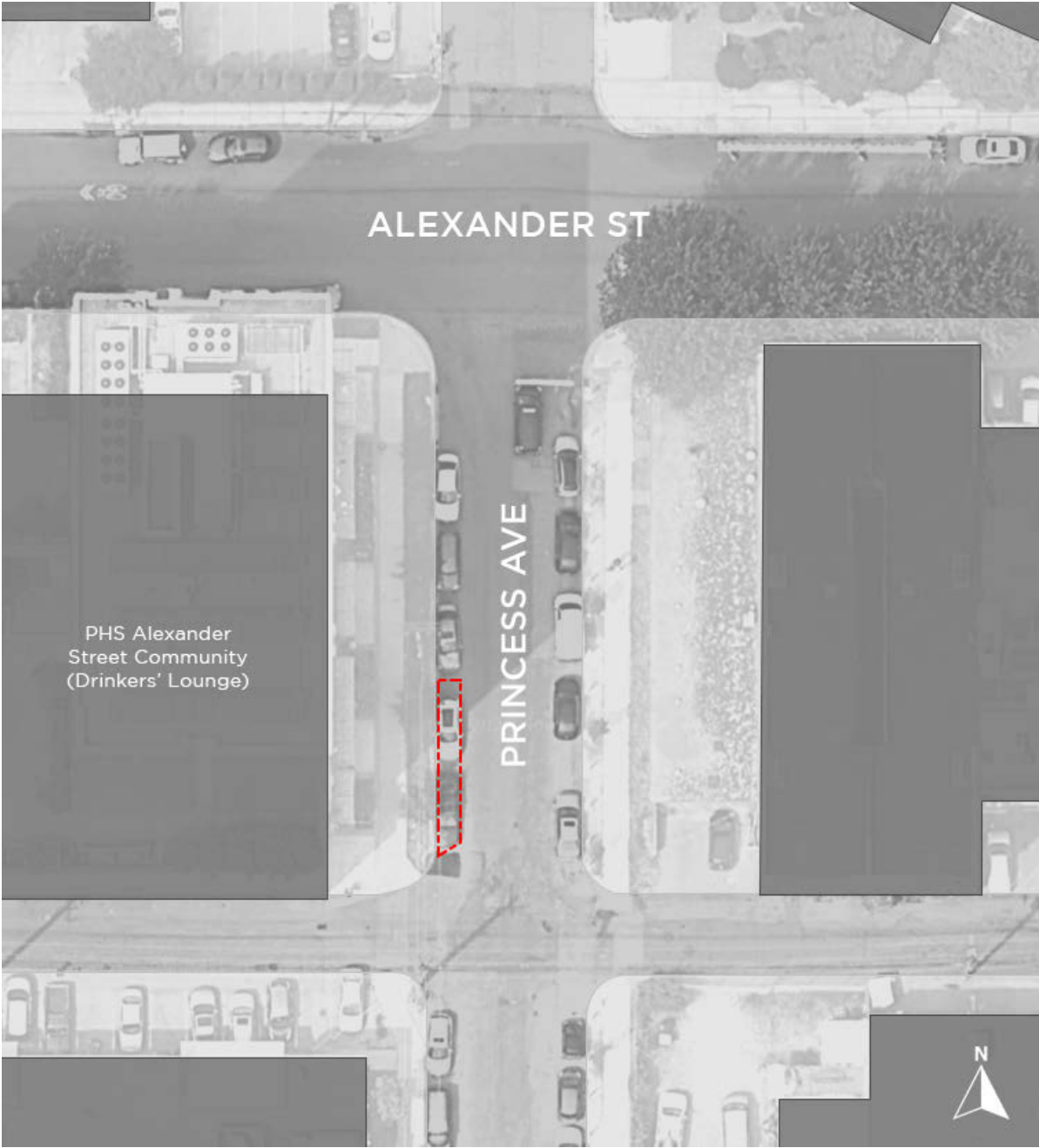
