SUBJECT: Continuation of Wedding Program at Vancouver City Hall

PURPOSE

The following memo provides a one year status report on the micro-wedding pilot program launched in May 2020, and outlines a plan to continue an ongoing wedding program at Vancouver City Hall.

BACKGROUND

On May 8, 2020, the City launched a micro-wedding pilot program to fulfill Council's December 18, 2018 motion entitled *Weddings at Vancouver City Hall*.

The pilot program offered 30-minute wedding ceremonies between June 2020 and May 2021 to couples wanting to safely marry at City Hall during the COVID-19 pandemic. Under the pilot, couples could invite up to 8 guests including an officiant, witnesses and vendors such as a photographer to attend a ceremony. Couples arranged their own marriage licence, officiant, and any decorations that could be packed in and out within their 30 minute timeslot. At the conclusion of the one-year pilot, 122 wedding ceremonies were made available and 110 ceremonies were booked and paid.

During the pilot, wedding ceremonies took place both outdoors on the Helena Gutteridge Plaza



and indoors in the Council Chamber. Couples paid an \$85 + GST non-refundable fee for outdoor weddings, and a \$275 + GST non-refundable fee for indoor weddings. The \$85 fee was a special fee offered in phase one of the pilot to help couples facing financial difficulties due to the economic impacts of COVID-19, and to attract enough couples to get married at City Hall to "test" the initial phase of the program. The \$275 fee was implemented in December 2020 to better reflect the costs of running the program and the added value to couples for exclusive use of the Council Chamber. Fees included:

- 1) non-exclusive use of the Helena Gutteridge Plaza or exclusive use of the Council Chamber:
- 2) third party liability insurance;

at City Hall again

- 3) physical distancing decals for guests, officiants and couples to keep a safe distance from one another as per COVID-19 safety protocols, a document signing table and unlimited time on the City Hall campus to take photos; and
- 4) a dedicated City staff to facilitate bookings, monitor and implement COVID safety and sanitizing procedures, coordinate payment, process user agreements, and manage day-of wedding logistics.

An online survey was sent to couples and officiants after each ceremony. The following table is a summary of the responses received and Appendix A of this memo provides examples of written comments received through the survey:

An initial start up budget of \$25,000 was provided from the 2020 Emerging Priorities Fund to cover the cost of research and program development. Revenue earned from 2020 wedding bookings reached \$13,270 by year end. For the first 5 months of 2021, revenue has reached \$11,370 and is on track to reach \$51,000 by year end with total expenses projected at \$50,700.

Staff may consider raising fees for weddings once restrictions on public gatherings are lifted and larger weddings are permitted at City Hall to ensure that any additional costs associated with larger weddings are recovered. However, every effort will be made to keep fees as low as possible to make weddings affordable and accessible.

DISCUSSION

Ongoing Wedding Program

Given the positive feedback and the high demand for safe, affordable wedding venues, staff recommend continuing the wedding program on a permanent and ongoing basis.

For the remainder of 2021, micro-wedding will continue inside City Hall due to anticipated noise from construction on the Broadway Subway this summer, which will negatively impact outdoor weddings on the Helena Gutteridge Plaza. Once construction concludes on Broadway, outdoor weddings will resume on the Helena Gutteridge Plaza during summer months and inside City Hall during winter months.

The ongoing wedding program will allow couples to:

- Book 30-minute time slots online at vancouver.ca/weddings to get married outside or inside City Hall. On average, two dates per month will be made available for wedding ceremonies. Exceptions will include high demand months such as July with an extra date designated for LGBTQAI2S+ during Pride Week. All designated wedding dates will be on non-Council meeting days.
- Invite up to eight guests including the officiant and witnesses until restrictions on public gatherings are lifted. Once restrictions are lifted, staff will increase capacity to 20 guests for indoor weddings and 30 for outdoor weddings
- Obtain a marriage licence prior to the ceremony, and arrange for their own officiant. Marriage licences are available at the London Drugs Insurance Services on Broadway Street close to City Hall. Couples will continue to arrange their own officiant. Staff investigated the possibility of hiring one officiant to perform weddings at City Hall on a charge-back basis; however, Vital Statistics does not allow its registered Marriage Commissioners to work exclusively for a venue. Religious officiants work under a different set of rules and are permitted to work exclusively for a wedding venue; however, as a civil wedding program, the City will not pursue this option. Furthermore, selecting an officiant is a personal choice made by the couple.
- Bring sustainable decorations to be set up and removed within the 30-minute time slot. Confetti, rice or flower petals will not be permitted in the Council Chamber or outside on the Helena Gutteridge Plaza.

• Pay a booking fee of \$275 + GST for a wedding ceremony at City Hall. The fee would include exclusive use of the Chamber or non-exclusive use of the Helena Gutteridge Plaza for 30 minutes, basic set up, a document signing table, and third party liability insurance. The fee would also include the services of a City wedding coordinator to safely facilitate the move in and move out of wedding parties throughout the day, tidy and sanitize high-contact areas between ceremonies, and monitor adherence to COVID-19 safety protocols. Payment in full is required to confirm the booking and no refunds would be issued in case of cancellation. Staff will consider raising fees once restrictions on public gatherings are lifted and larger weddings are permitted to ensure that any additional costs associated with larger weddings are recovered.

Available dates for City Hall weddings will be posted on vancouver.ca/weddings six months prior to the scheduled wedding date. For the remainder of 2021, the following dates will be made available:

- June 3 and 4
- July 9, 16 and 26 July 26 will be a special wedding date exclusively for LGBTQAl2S+ couples to get married at City Hall during Pride Week. It will be organized in partnership with the Vancouver Pride Society. July 26 weddings will take place in the Joe Wai Room to accommodate a large decorative archway provided by Vancouver Pride Society.
- August 5, 6, 26 and 27 weddings will take place in the Mayor's Ceremonial Office as the Council Chamber is unavailable due to system upgrades.
- September 2 and 3
- October 8 and 15
- November 19
- December 10 and 17

Staff will monitor the program's bookings on a continuous basis. If demand for weddings start to drop, staff will reduce the number of designated dates available to ensure the program remains cost recovery. Conversely, if demand for weddings continues to rise, staff will add dates to meet demand.

Other Considerations

As per the December 2018 motion, staff considered options to work with Technology Services and the Vancouver Park Board to streamline the registration process for weddings; however, the initial programming cost of adding Vancouver City Hall weddings to Park Board's ActiveNet system was estimated at \$5000-\$7000 with ongoing monthly fees. For now, City Hall weddings will utilize its own online registration and payment system. New registration and payment solutions will be sought if supported by continued and adequate demand. ActiveNet will be considered as a solution option with a final determination being driven by costs and cost-recovery. It is the City's preference to leverage existing applications/solutions where possible.

It should be noted that informal coordination between staff that coordinate wedding activities at the Park Board, Civic Theatres and City Hall is taking place to share lessons learned and ensure policies and fees are relatively aligned; however, at this time, there is no plan to formally coordinate the various programs given that each wedding venue has its own unique services and brand.

CONCLUSION

In conclusion, staff will continue the micro-wedding program indoors at City Hall to help couples wanting an affordable, reliable, and safe wedding venue during the COVID-19 pandemic and beyond. The pilot filled an immediate need for couples and officiants wanting to continue with wedding plans during this public health emergency, and has demonstrated that a full-scale wedding program is viable and can operate as a low-cost option and on a cost recovery basis.
