SUBJECT: Four week pilot project for the provision of menstrual supplies in washroom

trailers

PURPOSE

This memo provides information regarding the proposal of a four week pilot project to distribute menstrual products at 2 of 3 recently deployed washroom trailers. The product will be free of cost to the user and distributed by the site leads or peer support individual at the trailer sites. The site of the 3rd trailer already has this service. These stations are key community resources in addressing vulnerabilities within our dual public health emergencies across response and recovery phases of the pandemic, ensuring the City meets the basic necessity for menstrual products is integral for ensuring access to hygiene.

BACKGROUND

The COVID-19 crisis created strain on vulnerable people who experience menstruation. Menstruation products are a basic necessity, but when living in poverty or are vulnerable in other ways – access to tampons, pads, cups or menstrual underwear, can be challenging.

According to a study by WISH, 75% of female sex workers are unable to pay for groceries, rent, and basic supplies (including menstrual products). Additionally, there are people who experience menstruation/monthly bleeding who do not identify as women (they may be gender diverse, non-binary, trans men, etc who make up 5% of Vancouver's homeless population) and also face a loss of income and may find it difficult to maintain menstrual hygiene.



For context, based on the data from the 2019 Vancouver Homeless Report the following

populations may be impacted by this service.

Number of homeless females	Number of homeless Transgender Menstruators	Number of homeless menstruators	Total number of menstruators accessing washroom trailers
132	14	146	200

SUMMARY OF ACTIONS

Using \$5,000 of the Canadian Medical Association Foundation funding for washroom trailers, the EOC will purchase menstrual products and introduce a 4 week pilot project to provide a free of cost to user at 2 (Site 1 & 2) of the 3 locations.

At Site 1 and 2, the product will be distributed by the site leads/peer network

Site 1: Wish Drop-In Location, 334 Alexander St

Open and Monitored: 24/7

Site 2: OPS, 62 E Hastings St

Open and Monitored: 8 am – 8 pm

- Site 3: Church of Nazarene 998 E 19th Ave
 - RainCity is currently providing menstruation products at the Kingsway Church of Nazarene location.

The assumption is that \$5,000 will provide enough product for a 4 week supply at Site1 and 2 and staff will work closely with site leads to monitor supply levels.

FOLLOW-UP ACTION

- 1. The EOC will coordinate the logistics of delivery to the first two sites.
- 2. The products will be operationally managed by location leads and distributed in the same manner as harm reduction supplies.
- Over the 4 week, the EOC will monitor the progress and report back findings of this pilot project.
