Doug Smith has provided the following detail regarding the City-owned chargers:

There are stations we own and operate: about 9 DC Fast Chargers and roughly 30 Level 2s. Several more of each will be up and running by year's end.

We own them and pay all operating costs, and get revenue back. Capital costs have been funded using City funds coupled with grants from provincial and federal government grants. The revenues partially cover some of the operating costs.

Good morning Christine,

Our staff team has provided the following comments in response to your question below:

With regards to the references in CEPP, the City investment is for City-owned and operated charging stations and their installation. This investment will expand the City's network of public chargers, which includes fast charging hubs and level-2 chargers throughout the city. By the end of the year, a DC Fast Charging hub will be located within a 10-minute drive of most parts of Vancouver. The City also hosts several BC Hydro public chargers on City land, which haven't required City investment. Private operators will continue to install some chargers on private property to attract customers but in order to support faster EV uptake to hit our targets we'll need a network of city owned/operated chargers on public land.
