Dear Mayor and Council,

The attached memo relates to the upcoming Provincial Election on October 24, 2020 and ensuring that all employees have a four hour period to vote. A brief summary is as follows:

- ☐ The Elections Act RSBC [1996] Chapter 106 requires an employer to ensure that an employee has four (4) consecutive hours free during the time polls are open (8:00 am to 8:00 pm) on General Voting Day for the purpose of voting.
- ☐ The General Voting Day is set for a Saturday which means that City Hall, West Annex and Crossroads Building will not be open to the public, but staff who are working in those facilities or in other work locations whose hours of work are between 8:00 am and 8:00 pm must be permitted four (4) consecutive hours to vote at the end of the day.
- ☐ Employees will not lose pay for leaving to vote before the end of their shift if it is within the four-hour period. Mangers are required to approve the time away from work and provide appropriate coverage.

SUBJECT: Provincial Election – Saturday, October 24, 2020

Dear Mayor and Council,

The *Elections Act RSBC [1996]* Chapter 106 requires an employer to ensure that an employee has four (4) consecutive hours free during the time polls are open (8:00 am to 8:00 pm) on General Voting Day for the purpose of voting. The Act allows the employer to set this four-hour voting period. If an employee's working hours allow for four (4) hours free from work during the time polls are open, then no further arrangements need to be made.

The General Voting Day is set for a Saturday which means that City Hall, West Annex and Crossroads Building will not be open to the public, but it is imperative that any staff who are working in those facilities or in other work locations whose hours of work are between 8:00 am and 8:00 pm are permitted four (4) consecutive hours to vote at the end of the day. In departments where it is not operationally possible to close at 4:00 pm, or where shift arrangements are in place, please ensure that employees have four consecutive hours free between 8:00 am and 8:00 pm.

Employees will not lose pay for leaving to vote before the end of their shift if it is within the four-hour period. Mangers are required to approve the time away from work and provide appropriate coverage.

Civic Engagement and Communications staff will send out a news release to inform the media and the public of this one-time change in operating hours, and signage will be posted at door entrances.
