Dear Mayor and Council,

We would like to advise you that the City has formally received a rezoning application for the City-owned site at 2086-2098 West 7th Avenue, and 2091 West 8th Avenue (West 8th & Arbutus), for a social housing proposal. The application will be published on the City's Shape Your City website page tomorrow, October 13.

As some community members have previously raised questions to Council about this project, staff wanted to ensure you were aware of the timing of the application. BC Housing will be reconnecting with the community to inform them of the application submission and where the application will be available to them online. The City-hosted Virtual Open House will take place from November 1st – 21st. In addition, BC Housing and City staff will be reaching out to offer key stakeholders identified in the pre-application an additional opportunity to meet should there be any questions upon reviewing the application package.

In order to avoid any potential allegation of bias or that any Councillor did not have an open mind when considering this project following a public hearing, Council should refrain from expressing opinions on a rezoning application prior to the Public Hearing. Should Council receive questions or comments from the public, we would encourage Councillors to remain neutral in offering any feedback.

SUBJECT: Proposed Supportive Social Housing in Vancouver - West 8th Avenue at Arbutus Street

Project details

- A rezoning application has been received for a proposed social housing building at 2086-2098 W 7th and 2091 W 8th Avenue (West 8th Avenue at Arbutus Street) which could provide approximately 140 affordable studio homes with support services and indoor and outdoor amenity spaces for people experiencing or at-risk of experiencing homelessness.
- This project is part of the MOU between the City, BC Housing and the federal government to build approximately 350 supportive housing units over the next few years.
- More information is available on the BC Housing website here and the City's rezoning application where community members can learn more and share their feedback will be available here from Wednesday, October 13.

Key messages

 Vancouver is facing a housing crisis and people experiencing homelessness continue to be disproportionately impacted, especially during COVID-19. Creating new homes with supports help create safe, inclusive communities for everyone.



- The homelessness crisis requires a city-wide response because there are people
 experiencing or at risk of homelessness in all parts of the city. The City's Housing
 Vancouver strategy and community plans call for housing affordability and accessibility for
 all people in all communities.
- To address this crisis, a rezoning application for social housing at West 8th at Arbutus St. was submitted by VAHA on behalf of BC Housing on Monday, October 4, 2021. Community members can find out information and share their feedback during the virtual open house period. It will take place from November 1 until November 21, 2021 on the City's Shape Your City site: https://shapeyourcity.ca/. Following this period, there will be a public hearing for Vancouver City Council to hear directly from community members.
- Working together to build supportive housing is an important part of the collective action the federal government, the Province, and the City are taking to address the critical needs of people experiencing or at risk of experiencing homelessness in Vancouver.
- Building supportive housing ensures people in need have access to good quality, safe, affordable homes and are supported to stay in their homes and meet their personal goals.
- Studies have shown that the supportive housing model has been successful in communities across North America.
 - Example: <u>BC Housing Community Benefits of supportive housing</u>, <u>At Home/Chez Soi</u>
- This project is not a shelter or a Single Room Occupancy Hotel. Supportive housing
 provides residents with a studio apartment with private bathrooms and kitchenettes where
 residents make a choice to live there and pay rent. There are also outdoor and indoor
 amenity spaces for the residents including, a terrace, a dining area, program space, and
 laundry.
- Through a competitive process, BC Housing has selected MPA, an experienced non-profit
 housing provider with other housing and services in the local community, as the future
 operator of the proposed building.
- If the project is successful, MPA's staff will provide 24/7 staffing to support residents in their new homes, offer life skills training, meals, education, training and employment opportunities, and connect them to medical, health and wellness services, as needed.

FAQs

Q: What have you done to engage the community so far?

- Local residents and businesses were notified early in the process via fact sheet and personal door-to-door postcard deliveries inviting interested neighbours to attend Virtual Neighbourhood Dialogue Sessions.
- Four evenings of virtual Neighbourhood Dialogue Sessions were held with project partners in the pre-application phase to introduce the project, collect feedback and answer questions.
- Residents were also able visit <u>Let's Talk Housing</u> to view the housing proposal and submit their questions and comments to the project team.

 A dedicated Community Liaison continues to be available throughout the development process to answer questions about the project and, if approved, will continue to be available through the construction phase. The Community Liaison can be reachedcommunityliaison@bchousing.org or by calling 604-829-9321.

Q. What is supportive housing?

This deeply affordable social housing with the addition of on-site supports that enable
people to live as independently as possible. Supportive housing can help people stabilize
and improve their lives, help them stay housed and reconnect to communities. In supportive
housing, residents make a choice to live there and pay rent.

Q: How is supportive housing different than a shelter or an SRO?

 A shelter offers emergency and/or temporary place to sleep, not a permanent place to call home. This site is permanent social housing that provides customized supports and services for each resident to help them maintain their housing stability.

Q: How can the public find out more / share their feedback about the rezoning application?

- Community members can find out information and share their feedback by visiting the proposal's Shape Your City site during the rezoning application review phase: https://shapeyourcity.ca/. Furthermore, a City-hosted virtual open house will take place from November 1 until November 21, 2021 on the City's Shape Your City site, during which the public will have an opportunity to ask questions, and have responses posted publicly on the site. After the rezoning application review period, there will be a public hearing in order for Mayor and Council to hear directly from community members prior to making a decision on the rezoning application.
