Dear Anita, Mayor and Council,

The approval of the Climate Emergency Action Plan does not provide approval to implement transport pricing in Vancouver. The work plan includes two key milestones that will require further Council approval to move forward and will include a report back in 2022 focused on stakeholder engagement and feedback. Council clearly supported the concept of transport pricing and directed staff to proceed with the work plan in a way that puts the City in a position to launch a system in Vancouver in 2025, if approved by Council.

In the news release, it would have been more accurate if we had used "plan for" rather than "implement" transport pricing in the metro core by 2025.

- Through robust consultation, create a model to implement transport pricing in the metro core by 2025 to reduce congestion and reallocate road space to more sustainable modes and increase walking, rolling, cycling and transit use

We have clarified that in a revised statement that was shared with media.
