# A. Purpose

This memo provides Council with an update on the work of the City of Vancouver's United Nations Declaration on the Rights of Indigenous Peoples ("UNDRIP") Task Force, and lays out the Task Force's workplan through 2022. This Task Force is a City of Vancouver Type D Advisory Committee, convened in partnership with the Musqueam Indian Band, the Squamish Nation, and the Tsleil-Waututh Nation.

# B. UN Declaration on the Rights of Indigenous Peoples

UNDRIP is recognized as the most comprehensive international human rights instrument concerning Indigenous Peoples. It establishes the minimum standards for the survival, dignity and well-being of Indigenous Peoples and elaborates on existing human rights standards and fundamental freedoms in their unique and specific application to Indigenous Peoples individually and collectively.<sup>1</sup>

On February 26, 2013, Vancouver City Council ("Council") adopted a motion to endorse UNDRIP.

# C. UNDRIP Task Force Formation and Mandate

In accordance with the call from the Truth and Reconciliation Commission of Canada for all levels of government to adopt UNDRIP<sup>2</sup>, Council adopted a <u>motion<sup>3</sup></u> on March 2021, *Implementing the United Nations Declaration on the Rights of Indigenous Peoples*.

This Motion directed the establishment of a Type D Advisory Committee (UNDRIP Task Force) with participation from both elected officials from Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation ("MST") and City Councillors.

The Motion stated the UNDRIP Task Force will "develop recommendations on how the City of Vancouver can implement the UN Declaration on the Rights of Indigenous People as an integral aspect of its work on Indigenous relations and reconciliation".

# D. UNDRIP Task Force Structure

The Task Force is comprised of a Steering Committee and a Technical Committee. Appendix C contains a full list of a Task Force Steering Committee and Technical Committee members.

- a. The **Steering Committee** is made up of elected officials from the City of Vancouver, the Musqueam Indian Band, the Squamish Nation and Tsleil-Waututh Nation, and has the mandate of delivering a set of recommendations to Council concerning the City's implementation of UNDRIP.
- b. The **Technical Committee** is made up of staff from the City of Vancouver, the Musqueam Indian Band, the Squamish Nation, the Tsleil-Waututh Nation, and local urban Indigenous organisations, with the mandate of undertaking the technical work required to support the Steering Committee's decision-making process.

To help inform the recommendations, the Task Force may seek external expertise, including legal, academic, Traditional Knowledge and lived experience. In 2022 the Task Force will be exploring the potential for broader Indigenous community engagement.

# E. UNDRIP Task Force Key Achievements to Date

The Task Force has accomplished the following since its first meeting in July, 2021:

1. Convened the Task Force Steering Committee. While the establishing Council motion stated that up to two representatives from each of the Nations would be appointed to the Task Force Steering Committee, the Task Force Steering Committee decided on October 1, 2021 that an additional (third) appointment from Musqueam with particular legal and UNDRIP-related experience would be made to supplement the Task Force.

- 2. Appointed Steering Committee Co-Chairs: Councillor Boyle (City of Vancouver) and Council Chairperson Khelsilem (Squamish Nation). Co-Chairs will alternate chairing meetings, and openings will be provided by the Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation on a rotating basis.
- 3. *Staffed the Technical Committee.* The Technical Committee will convene in late fall and will meet regularly thereafter, to provide technical support to the Steering Committee as required.
- 4. Developed Task Force Protocols. The Task Force Steering Committee has approved a Protocols document which outlines principles for how the Task Force will operate, such as communications, decision-making and technical assistance. The Task Force has agreed to strive to make decisions by consensus.
- 5. *Approved an approach for external expertise*. The Task Force Steering Committee has agreed to a process and criteria for selecting external experts and advisors.
- 6. *Initiated discussions on engaging diverse Indigenous communities*. The Task Force will be further discussing this item in 2022.
- 7. Agreed to recommendations and report approach. The Task Force has approved an approach for developing recommendations, including an outline and desired outcomes for each meeting in the workplan, as well as the timing and approach for Council updates and reports.
- 8. Approved a 2021/22 workplan and budget. Details of which are provided below.

# F. UNDRIP Task Force Workplan Details

The Task Force's recommendations will be developed in alignment with the four themes of the Provincial Declaration on the Rights on Indigenous Peoples Act (DRIPA) Draft Action Plan<sup>4</sup>:

- Social, cultural and economic well-being
- Ending Indigenous-specific racism and discrimination
- Self-determination and inherent right of self-government
- Title and rights of Indigenous Peoples

In developing recommendations, the Task Force will have access to a summary of City of Vancouver initiatives related to reconciliation which may support one or more of the themes. The Task Force will take these ongoing or planned initiatives into account when developing recommendations, and may also make recommendations regarding prioritization of City initiatives. The Task Force may identify early actions at the conclusion of each theme.

# G. Budget

As part of the 2022 budget process, Council allocated \$0.2 million in ongoing funding to the UNDRIP Task Force and related Indigenous work. These funds will be used to (a) hire a new regular full-time Indigenous Relations position into the Intergovernmental Relations department, and (b) engage external Indigenous legal expertise as required, for the UNDRIP Task Force as well as other Indigenous-related matters as they arise over time.

To complete the current workplan, a further \$0.3 million of one-time costs are anticipated for 2021/22. These costs will be funded out of the existing operating budget and/or potential external funding.

# H. Collaboration with Concurrent Provincial and Federal Government Processes

Both the provincial and federal governments have enacted legislation to implement UNDRIP, in 2019 and 2021, respectively. The Task Force will take into consideration provincial and federal commitments and jurisdiction when developing recommendations for Council.

<u>Provincial</u>: The Province released a draft Declaration on the Rights of Indigenous Peoples Act (DRIPA) Action Plan in June 2021 outlining provincial actions to implement UNDRIP and advance reconciliation. The DRIPA Action Plan identifies 79 actions that the Province aims to

accomplish in cooperation with First Nations between 2021 and 2026. In September 2021, the Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation made a joint submission to the draft DRIPA Action Plan consultation process. Mayor Stewart sent a letter on behalf of City Council and the Co-Chairs of the UNDRIP Task Force expressing the City's strong support for this MST submission (Appendix D). The City also worked with the Union of BC Municipalities to provide feedback concerning the Province's draft DRIPA Action Plan.

<u>Federal</u>: The federal government will be undertaking consultation on the federal action plan for the United Nations Declaration on the Rights of Indigenous Peoples Act (Bill C-15, passed June, 2021). At the time of this memo, timing for this to be initiated is not known.

<u>Missing Indigenous Women and Girl's Calls to Justice & Red Women Rising:</u> In parallel with the work of the City of Vancouver's UNDRIP Task Force, the City is working on many other Indigenous-related initiatives, include actions to operationalise the recommendations of the Murdered, Missing Indigenous Women and Girls' Calls to Justice and the related Red Women Rising Report.

# I. Next Steps

The Task Force has begun developing recommendations under the first theme (social, cultural and economic well-being), according to the workplan shown in Table 1. Approximately half-way through the workplan, in May 2022, the Task Force will submit a mid-point report to Council, to include recommended early actions.

The recommendations in the Task Force's final report will have staff exploring the feasibility and implications associated with the implementation of each proposed initiative, and reporting back to Council with this analysis and recommendations concerning implementation. The Task Force's final report will be presented to Council in October 2022 with a recommendation for Council to endorse its recommendations and refer to the next Council for approval.

#### APPENDIX B - UNDRIP Task Force Terms of Reference (from March 9, 2021 Council Motion)

This will be a Type D Committee, and will provide recommendations to Mayor and Council for priority actions that may be taken by the City to implement the UN Declaration on the Rights of Indigenous Peoples.

The scope of the committee's work will include:

- Consult and collaborate with the Musqueam, Squamish, and Tsleil-Waututh on the development of the Committee's Report;
- Provide recommendations on how the City can implement the UN Declaration on the Rights of Indigenous People in the City of Vancouver as an integral aspect of its work on Indigenous relations and reconciliation;
- Consult and engage Indigenous peoples and Indigenous groups in the City of Vancouver on recommendations for implementing the UN Declaration on the Rights of Indigenous People in the City of Vancouver;
- Consider the role of UNDRIP and the urban Indigenous communities today living in Vancouver, recognizing the importance of both title and rights in UNDRIP implementation;
- Build on past and current work in the City of Vancouver on reconciliation and the implementation of UNDRIP;
- Consider the BC Declaration on the Rights of Indigenous Peoples Act (DRIPA) as a model;
- Create a high-level work plan and a budget to carry out the recommended actions to implement the UN Declaration within the City of Vancouver, to be included for consideration in the 2022 city budget process as well as a review of current City projects involving Indigenous peoples and a work plan to bring them in line with the articles of the UNDRIP;
- Seek ways to engage women, youth, and elder voices in the development of the report's recommendations.

# Composition

This committee is a Type D Committee that will provide a report to the Mayor and Council upon completion.

The committee will consist of up to two representatives from each of the Musqueam, Squamish, and Tsleil-Waututh Nations, along with Councillor Boyle and up to 3 other representatives from Mayor and Council. Two Steering Committee Co-Chairs will be appointed by the committee.

The Steering Committee will engage with and work to ensure representation of leadership that

reflects the diversity of the urban Indigenous community. Members of Council will be invited to participate in working groups at the request of the Co-Chairs.

The committee will be supported by a technical team of experts and advisors. That technical team could include staff from the Musqueam, Squamish, and Tsleil-Waututh Nations as chosen by the Nations, and staff from the City of Vancouver at the direction of the City Manager, as well as additional advisors and external experts.

### **Budget and Staff Support**

The City Manager will be responsible for allocating staff resources as appropriate, including any recommendations for reprioritizing current staff work on Reconciliation to align with the implementation of UNDRIP. The City Manager will also assess resources and report back to the Mayor and Council on any recommended capacity resources to support Musqueam, Squamish, and Tsleil-Waututh Nations participation, as well as opportunities to seek funding support from senior levels of government.

#### Timeline

An update report including a work plan and requested budget will be presented to Council by the end of Q3 2021 or earlier.

#### WHEREAS

- 1. The City of Vancouver has made significant long-term commitments as a City of Reconciliation, and has taken many steps to advance reconciliation. The City can continue to deepen its commitment to reconciliation with measurable actions and systemic change;
- 2. Earlier this year, Vancouver City Council unanimously passed a motion to implement the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP);
- 3. This work has been supported by Musqueam, Squamish, and Tsleil-Waututh Nations, including through participation in a shared Taskforce on Implementing UNDRIP in the City of Vancouver;
- 4. The BC government is seeking feedback from Indigenous peoples on their draft action plan required under the Declaration on the Rights of Indigenous Peoples Act until July 31, 2021.

THEREFORE BE IT RESOLVED THAT Council request the Mayor on behalf of Council, and Councillor Boyle, as Co-Chair of the UNDRIP Task Force, further to a motion from the UNDRIP Task Force, to write a letter expressing support for the anticipated request from Musqueam, Squamish, and Tsleil-Waututh Nations to the provincial government to provide appropriate resources and support to municipalities to implement the Provincial DRIPA Action Plan.
