EXECUTIVE SUMMARY

November 4, 2011

The Payroll / Time Entry Process CAAT (Computer Assisted Audit Tool) audit was initiated to provide reasonable, independent assurance that the existing internal controls and business processes were adequate and effective.

In our opinion, internal controls over the payroll and time entry processes require improvement. Corporate Payroll has established certain internal controls to ensure the reasonableness of payroll. However, given the decentralized nature of time entry across the City, further improvements should be made to strengthen the control environment. The more significant findings and recommendations are:

F.1 Monitor pay grade/pay level changes through CATS

The purpose of the Employee Compensation Authorization Form (ECAF) is to ensure pay changes are authorized. However, we observed that pay grade/level changes made through SAP's time entry module (CATS) were not approved using an ECAF. Bypassing the ECAF process increases the risk of unauthorized changes. A process should be in place to monitor CATS entries for unusual pay changes on an on-going basis to ensure the changes are correctly approved.

F.2 Clarify the policy for additional time worked by exempt employees

The "Other Benefits" section of the Exempt Employee Handbook states that an additional one week of vacation is paid in recognition of the requirement to work overtime without additional compensation for exempt employees. However, we observed additional hours worked by exempt employees were being traded or 'swapped' for time off at a later date. This practice is non-compliant with current policies. The policies for additional hours worked by exempt employees should be clarified and communicated to departments.

F.3 Monitor time entries for employees who enter their own time

The Time Entry Policies and Procedures specify that time entry staff should not enter their own time. From SAP time entry data analyzed during this review, there were 106 employees who entered their own time. The policy for time entry should be re-iterated to time entry managers so that time entry responsibilities can be segregated where practical. Also, ongoing monitoring of time entries of employees who enter their own time should be performed to ensure they are properly reviewed by their managers.

These and other audit findings and recommendations are contained in the report.

EXECUTIVE SUMMARY

October 19, 2011

The City has centralized its procurement process under the Supply Chain Shared Services. The new centralized framework and Procurement Policy became effective in April 2010. Between April and December 2010, Supply Chain Management had processed approximately \$78 million of contracts centrally.

This Request for Proposal (RFP)/Invitation to Tender (ITT) audit was initiated to assess the adequacy and effectiveness of existing internal controls, efficiency of business processes, and extent of compliance with applicable policies and procedures.

In our opinion, the current procurement process requires improvement. Strengthening of the procurement internal controls, providing clarification within the new Procurement Policy and streamlining the purchasing activities can improve the overall process. The significant findings and recommendations are:
