As you know, staff are working to update the Vancouver Liquor Policy. To date, we have conducted background research, liaised with expert stakeholders, and started to develop initial policy directions. This spring, we are starting a broad community consultation on liquor policy to elicit general attitudes toward liquor and more specific policy directions. This outreach will target all interested community members, as well as specific interests such as the liquor industry, the arts and culture community, and health and safety advocates (see Attachment 1 for a list of key stakeholders to be consulted). A second consultation will take place in the fall after we workshop the issue with Council and develop policy options.

Staff will engage with the community via a short Talk Vancouver questionnaire that will be open for five weeks, meetings with key stakeholder groups, and outreach stations at two Popup City Halls (others may be added):

- 1. at Nat Bailey Farmers' Market on April 16, 10:00 am to 2:00 pm
- 2. at Hastings Park Farmers' Market on April 17, 10:00 am to 2:00 pm

To guide and advise on this work we are convening a Steering Committee of the departments that are involved in, or affected by, liquor issues and opportunities: Licences and Inspections, Planning, VPD, Corporate Communications, Legal Services and the Vancouver Economic Commission. We have also convened a technical working group with City and Vancouver Coastal Health staff to develop policy.

As mentioned, following the Spring consultation outreach, staff will update Council via a workshop (scheduled on June 13th). Over the Summer staff will prepare final draft liquor policy, and consult with the community again in the Fall. We aim to present final recommendations to Council before the end of this year.
